1 st Sept. 1820. REPORT.

The crops of wheat this year are excellent, and they have been harvested in the highest order; but a little equally good still remains to be cut. Indian corn at Majorville has never looked better, but owing to the continued drought its appearance on the high lands is not so favourable. The present year has been without exception the finest season for oats which this country has ever experienced; but barley is not by any means so good. Grass has throughout this county turned out exceedingly well, and it has been made in an excellent manner. Potatoes are expected to turn up large, but by no means abundantly, particularly on the high lands; and crops of Buck-wheat are not at all promising, much having entirely filed. The orchards look better than they have done of the years, and the productions of the gardens have completely answered out utmost expectations.
