Extract from the Massachusetts Agricultural Journal.

ON THE PREPARATION OF FLAX AND HEMP WITHOUT STEEPING.

[From the Repertory of Arts, Vol. 31.] " According to the census of 1810, 1,090,320 yards of flaxen cloth, and 60 yards of tow cloth were manufactured in one year in the State of Massachusetts. Hemp, of which 6000 tons were raised in a year in Kentucky, has been cultivated with success and profit on the interval lands of Connecticut river at Springfield and elsewhere. If the culture of these commodities has been progressive, which we have no season to doubt, nor that it wil continue so, it may be presumed that a respectable number of the farmers in Massachusetts have a direct interest in the information which the following paper discloses. No description is given, at full length, of the machines used in preparing the flax and hemp, but if the mind is satisfied that the process pointed out is preferable to water rotting, the mechani-, cal ingenuity of our countrymen will soon supply all that may be wanting to put them in full possession of the benefits of the discovery. The account, from Les Archives Philosophiques &c. of a similar process used in France, will be found interesting, and taken in connexion with that of the English, gives us the important fact, that the result of a simultaneous investigation of the subject in both countries, under authority of the respective governments, was a decided preference and recommendation of the new method over that by water steeping or dew rotting. A short abstract of the different statements would have afforded all that was substantially important to be known by us in this

country, but we thought it might not be wholly useless to show the manner in which the investigation was conducted in England."

COX applied to me to lend him some money, when to befriend him, I immediately gave to him the Bill just mentioned As I was then on my way to England, upon my own private concerns, JOHN S COX wished me to take a Power of Attorney from him to collect sundry sums which were due him in England, from several Officers who lately belonged to the late 98th Regiment, but on my making a presentation of these demands, their legality was refused, and I immediately returned to Fredericton in October last, and informed Mr. COX of the result, at the same time giving to him all the vouchers and his Power of Attorney; and as he stood indebted to me in the sum of £119, on the Bill of Exchange and on other accounts, I immediately applied to him for a settlement, with the interest, when he told me it was not in his power to pay the amount, and requested the indulgence of a further time; to this I readily agreed, not feeling a wish to embarrass him in any way, or to do him an injury, and he gave me 4 doubloons, together with a Note of Hand for the balance, being one hundred and five Pounds, which is the same note to which he refers in his advertisement, and becomes due in the present Month of May .
