On the 21st of April, the Grand Jury for the City of London, having gone thro' the business of the Sessions, presented the keeper of Newgate for not granting them permission to visit the state prisoners. Some altercation took place between the Court and Jury. The Court observed, that Mr. Brown, the keeper, had a most awful responsibility on his hands, and the Court could not say, that, in refusing the gentlemen of the Grand Jury admission to the prisoners, he had acted improperly. The Jury protested against the power exercised by the Court.

The Jury then proceeded to Newgate, and in the afternoon returned with the following presentment :---

" The London Grand Jury respectfully beg leave to present to the Court, that, in their opinion, the alarming increase of crime in the Metropolis, especially among the juvenile offenders, is to be chiefly attributed to the very inadequate state of Newgate Prison, for the purpose of classing the Prioners according to their various degrees of criminality ; thus, boys and girls, who may have been committed for some slight misdemeanors, are forced to associate with the basest and most hardened felons, and are consequently returned upon society (when the periods of their imprisonment are passed) In the possession of all the theory of the most practised offenders. The Grand Jury, therefore, earnestly implore the Court to give their most serious and immediate attention to this deplorable state of Newgate Prison, and to adopt such measures as shall effectually remove this great discredit from the Metropolis. The Grand Jury beg leave respectively further to present, that in the exercise of their duty they have been refused admission to that part of Newgate where the State prisoners are confined ; thus the rights and privileges which have been handed down from their predecessors to the Grand Jury, have, in their humble judgment, been infringed.
