So great was the anxiety to gain admission into the House of Lords, that many of the peer's carriages arrived before 10 o'clock; but positive orders had been given not to open any of the doors till twelve o'clock, not even to the peers themselves. This order was strictly enforced, and when the doors were opened, none but peers orders were admitted. Beside Palace yard being filled with carriages, a line of them reached to the end of Parliamentstreet by eleven o'clock.

His Majesty entered the house about two e'clock. Being seated on the throne, the Commons were summoned to attend at the bar, as usual, when the King delivered a most gracious speech, of which the following is an outline :-
