Caution against Fraud!

[Postscript to the Gazette.]

At the Inferior Court of Common Pleas for the County of York, held on Saturday the 25th March, instant, an order was entered for the appointment of the following persons Commissioners for taking Bail in the said Court:—viz.

JOHN BEDELL, Esquire, of Woodstock; RICHARD KETCHUM; Esq. do. JAMES A. M'LAUCHLIN, Esq. Military Settlement above Presque' Isle. PETER DU PERRA, Esq. Madawaska. ALEXANDER CAMPBELL, Esq. Nashwalk.

Reports have reached us from various quarters, stating that our venerable Sovereign GEORGE the THIRD, closed his life on the 29th January last. The death of His Royal Highness the DUKE of KENT is also mentioned. No official information, however, of these melancholy events has yet been received.

The following Bills have received the assent of his Excellency the Lieutenant-Governor:—

20TH MARCH 1820.

A Bill for granting further aid in support of the Grammar School in the Town of Saint Andrews.

A Bill to continue several Acts of the General Assembly that are near expiring.

A Bill to continue and make perpetual the Act for the preservation of River and Sea Banks or Dykes, that is near expiring.

A Bill for altering the Terms of holding the Court of General Sessions of the Peace and Inferior Court of Common Pleas in the County of King's.

A Bill to continue and amend An Act entitled "An Act for raising a Revenue in this Province." and to repeal the one made in amendment thereof.

A Bill to confirm the Charter of the Madras School in New-Brunswick and to extend the powers of the Governor and Trustees of the same.

A Bill to enable the Justices of the Supreme Court to enlarge the time of the sittings of the said Court, when the same shall be expedient.

22D MARCH.

A Bill to explain, amend and continue An Act intitled "An Act to encourage the raising of Bread Corn on New Lands."

A Bill to provide for the cancelling the Treasury Notes that have been issued in this Province.

A Bill to confirm and perfect and to carry into force and effect an agreement made between the Governor and Trustees of the College of New-Brunswick and certain Tenants of the said Governor and Trustees.

25TH MARCH.

A Bill to increase the Fees of Marshals in the City Court of the City of St. John, in certain cases.

A Bill to authorize and empower the Inferior Courts of Common Pleas in the respective Counties of this Province, to appoint Commissioners to take Bail in the same Courts.

A Bill for granting Bounties on Grain raised in this Province.

A Bill to incorporate sundry persons by the name of the President Directors and Company of the Bank of New-Brunswick.

A Bill in addition to an Act entitled "An Act to authorize the Justices of the Peace for the City and County of St. John to levy an assessment on the Inhabitants of the said City, for the purpose of building a Poor House in the said City.

A Bill to provide for sick and disabled Seamen, not being Paupers belonging to the Province.

A Bill to provide for opening and repairing Roads and erecting Bridges throughout the Province, and improving the navigation of certain Rivers therein.

A Bill to appropriate a part of the Public Revenue for the services therein mentioned.

A Bill to appropriate a further part of the Public Revenue for the services therein mentioned.

A Bill for the further increase of the Revenue of the Province.

Come forward then and proclaim yourselves citizens of the world, friends to the best kind of charity and promoters of the general good, by encouraging the cultivation of the soil. Be assured that your endeavors will meet with ample reward, for

To the Editor of the Royal Gazette.

Sir,—With astonishment I view the wonderful apathy with which our fellow countrymen look on that Institution which is founded for their own immediate benefit, which is likely to tend to the prosperity of the Province, as well as to the general interests of the world at large, by improving the culture of the soil and increasing the growth of that which is the staff of life; and which may be the means of causing the forests of New-Brunswick, and perhaps of all America, to vanish from our view, no longer leaving a vast exuberant waste around our cottages and farms to blast our rising grain and to harbour wild and destructive beasts.

With proper care and protection the society will give a spur to agriculture and to the rearing and fattening of cattle; and then perhaps in the course of a few years, instead of the horrid, rugged wilderness now before us, we shall see the forest on all sides give way to our axes, large and valuable farms laid open to our sight, and the prospects pleasingly interspersed with houses, stacks of hay and grain, cattle grazing on the rich lowlands, and the verdure of the hills variegated with large flocks of sheep; plenty shall crown the labours of the husbandman; and the cataracts and rapid torrents rushing from the mountains, branching into streams meandering through corn fields and rich pastures, enrapture the traveller's soul. No more shall we see the unhappy peasant quitting the country in which he had promised himself ease and plenty;—no more shall the heart-broken and weary emigrant lead his wretched family to other climes in search of that bread for which he has quitted the place of his birth and bid an eternal adieu to his friends and former companions; but finding here a peaceable abode, they will add strength to our industrious population, increase the wealth and power of our growing country, call forth all its latent advantages, and raise our importance in the eyes of the parent country and the neighbouring nations. These advantages will endear this Province to the settler, and induce him to adopt it as his own:

So the loud torrent and the whirlwind's roar, But bind him to his native mountains more. Such shall be the advantages attending the operation of the Agricultural Society; besides this solid benefit to ourselves of enjoying the sweet consolation that our endeavours have contributed to the prosperity of a nation, and eminently conducive to the happiness of mankind at large. PARISH POOR.

THERE are at present a number of sick Paupers looking to the Overseers for daily support. It is well known that food cannot be obtained at this season without prompt payment. There are also several bills for the care of the sick brought against them which they cannot discharge—no means having as yet been placed at their disposal. From the present wretched mode of providing for the sick they must of necessity suffer; but if the Parish can afford them but one poor meal a day, that should be made sure to them. I do not wish a Pauper to call on me the second time for what the Parish allows and places at my disposal. I am also willing to do my part in improving the condition of the sick, but do not wish to have them looking to me when I have not the means of relieving them. I have assisted in providing for them during the winter—I have visited them frequently and expended a considerable sum for their relief, but have not yet received a shilling—neither can I learn when I am to have any thing. Complaints will probably be made; but as I attach blame to no one, so neither do I wish to be blamed.

If I had seen any prospect of an alteration in this system, I should not have made this statement; but having been placed in the gap, I do not wish the cries, much less the curses of the Poor to follow me. PETER FISHER. Fredericton, 27th March 1820.
