WHEREAS the General Assembly of this Province stands prorogued to Wednesday the fifth of this instant September: I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to the first Wednesday in December next ensuing.

SUCH of the Military Allotments of Land, as shall be found unoccupied or uncultivated by the Original Locatee on the 1st of May 1822, will be forfeited and revert to the Crown, and be open to application after the above period.

The Coronation.

The festivities of the day commenced at 1 o'clock this morning with the ringing of bells and firing of cannon. The streets shortly afterwards exhibited an animated scene. Continuous lines of carriages were seen advancing in perfect order along the prescribed routes, each side of which were thronged by an immense multitude in holiday attire, eagerly hastening to take possession of the places engaged, or to secure positions which might command a glimpse of the splendid pageant.

London and Oxford.

The persons representing these two Cities approached the temporary landing place in the Speaker's garden in the city's barges, early in the morning. Besides the Lord Mayor, Sheriffs, and Aldermen, of London, there was twelve citizens, selected from the masters of the twelve leading companies, with one alteration on account of a death since the first approval of the Court of Claims. The twelve citizens of London were,

They were attended by the City Officers, the Recorder, the Town Clerk, &c.

The Mayor and Burgesses of Oxford who claimed, under Charter, to assist the Citizens of London in the Butlership, were,

Herbert Parsons, Esq. Mayor; William Elias Taunton, Esq. Recorder; Richard Cox, Esq. Alderman; Thomas Fox Bricknell, Esq. Alderman; William Folker, Esq. Assistant; James Adams, Esq. Assistant; Robert Juggins, Bailiff; Charles Foster, Esq. Bailiff; Sir William Elias Taunton, Knight, Town Clerk.

They were permitted, as matter of favour, not of right, to proceed to the Hall in the City's barges.

The several persons who walked in the procession, assembled at an early hour this morning, in the following places, viz.

In the House of Lords—Their Royal Highnesses the Dukes of the blood-royal in their robes of estate, having their coronets, and the Field Marshals their batons in their hands. The Peers in their robes of estate, having their coronets in their hands. His Royal Highness the Prince Leopold, in the full habit of the Order of the Garter, having his cap and feathers in his hand. The Archbishops and Bishops, vested in their rochets, having their square caps in their hands.

In his place near the bar—The Gentleman Usher of the Black Rod.

In the space below the bar of the House of Lords—The Trainbearers of the Princes of the Blood Royal—the attendants on the Lord High Steward, on the Lord Chancellor, the Lord High Constable, and on the Lord Chancellor of the Household. The Gentleman Ushers of the White and Green Rods, all in their proper habits.

In the Painted Chamber, and adjacent rooms near the House of Lords—The Lord Chief Justice of the King's Bench; the Master of the Rolls; the Vice-Chancellor; the Lord Chief Justice of the Common Pleas; the Lord Chief Baron; the Barons of the Exchequer, and Justices of both Benches; the Gentlemen of the Privy Chamber; the Attorney and Solicitor General; Sergeants at Law; Masters in the Chancery; the Lord Mayor, Aldermen, Recorder and Sheriffs of London; King's Chaplains, having dignities; six Clerks in Chancery.

In the Chamber formerly the House of Lords—the Knights Grand Crosses of the Order of the Bath in the full habit of the order, wearing their collars; their caps and leathers in their hands. The Knights Commanders of the said order, in their full habits; their caps and leathers in their hands. The officers of the said order, in their mantles, chains, and badges.

In the chamber formerly called the Prince's chamber, or Robing-room, near the former House of Lords—The Treasurer and Comptroller of the Household; the Vice Chamberlain; the Marquis of Londonderry, in the full habit of the Order of the Garter, having his cap and feathers in his hand; the Registrar of the said Order, in his mantle with his book; Privy Counsellors, not being Peers or Knights Grand Crosses of the Bath; Clerks of the Council in ordinary.

In his Majesty's robing chamber, near the south entrance into Westminster hall—The Trainbearers of his Majesty; Master of the Robes; Groom of the Robes.

In the room of the Chairman of Committees adjoining the House of Lords—Lords and Grooms of the Bedchamber. The Keeper of the Privy Purse. Equerries and Pages of Honour. Gentlemen Ushers and Aids-de-Camp.

In the witness room adjoining the House of Lords, Physicians, Surgeons, and Apothecaries.

In the House of Commons and the Lobbies—Officers of the band of Gentlemen Pensioners with their corps, and the Sergeant at Arms. The officers of the Yeomen of the Guard, with their corps.

In the Lobby between the House of Lords and the Painted Chamber—The Kings, Heralds, and Pursuivants at Arms.

In Westminster Hall, at the Lower end, near the great north door. The sixteen Barons of the Cinque Ports, in their proper habits, with the canopy.

In Westminster Hall near the north door, the Knight Marshal and his two officers, in their proper habits.

In Westminster Hall, at the Lower end—his Majesty's Band.

Without the north door of Westminster Hall—All who are to precede the Knight Marshal in the procession.

His Majesty having entered his Chamber near the south entrance into Westminster Hall—

The Peers were called over in the House of Lords by Deputy Garter; and proceeded to the Hall, where the other persons appointed to walk in the procession had been previously marshalled on the right and left by the Officers of Arms; leaving an open passage in the middle, so that the procession, with the regalia, might pass uninterruptedly up the Hall.

His Majesty, preceded by the great Officers of State, went then into the Hall, and took his seat in the chair of state at the table, when a gun was fired. The Deputy Lord Great Chamberlain, the Lord High Constable, and the Deputy Earl Marshal, ascended the steps, and placed themselves at the outer side of the table. The Lord High Steward, the Great Officers, Deputy Garter, and Black Rod, arranged themselves near the Chair of State; the Royal trainbearers on each side of the Throne.

The Lord Chamberlain, assisted by officers of the Jewel-office, then brought the sword of state to the Lord High Constable, who delivered it to the Deputy Lord Great Chamberlain, by whom it was laid on the table; then Curtana, or the sword of mercy, with the two swords of Justice, having been in the like manner presented, were drawn from their scabbards by the Deputy Lord Great Chamberlain, and laid on the table before his Majesty; after which the gold spurs were delivered, and also placed on the table. Immediately after, a procession, consisting of the Dean and Prebendaries of Westminster in their surplices and rich robes, proceeded up the Hall, from the lower end thereof, in the manner following:

Procession with, and delivery of the Regalia.

Sergeant of the Vestry, in a scarlet mantle.

Children of the King's chapel, in scarlet mantles, four abreast.

Children of the choir of Westminster in surplices, four abreast.

Gentlemen of the King's chapel, in scarlet mantles, four abreast.

Choir of Westminster, in surplices, four abreast.

Sub Dean of the Chapel Royal.

Two Pursuivants at Arms.

Two Heralds.

The two Provincial Kings of Arms.

The Dean of Westminster, carrying St. Edward's crown on a cushion of cloth of gold.

First Prebendary of Westminster, carrying the orb.

Second Prebendary, carrying the sceptre with the dove.

Third Prebendary, carrying the sceptre with the cross.

Fourth Prebendary, carrying St. Edward's Staff.

Fifth Prebendary, carrying the chalice and paten.

Sixth Prebendary, carrying the Bible.

In this procession they made their reverences, first at the lower end of the Hall, second about the middle where both the Choir opening to the right and left formed a passage, through which the Officers of Arms passing opened likewise on each side, the Senior placing themselves nearest towards the steps: then the Dean and Prebendaries having come to the front of the steps, made their third reverence. This being done, the Dean and Prebendaries being come to the foot of the steps, Deputy Garter preceding them (he having waited their coming there) ascended the steps, and approaching near the table before the King, made their last reverence. The Dean then presented the Crown to the Lord High Constable, who delivered it to the Deputy Lord Great Chamberlain, and by him it was placed on the table before the King. The rest of the regalia was severally delivered by each Prebendary, on the knee, to the Dean by him to the Lord High Constable, by him to the Deputy Lord Great Chamberlain, and by him laid on the table. The regalia being thus delivered, the Prebendaries and Dean returned to the middle of the Hall. His Majesty having commanded Deputy Garter to summon the Noblemen and Bishops who bore the regalia, the Deputy Lord Great Chamberlain, then taking up the several Swords, Sceptres, the Orb, and Crown, placed them in the hands of those by whom they were carried.
