It was in these moments that he almost won us into enthusiasm; and we beheld him more glorious in his solitary and loveless exile, submitting to every privation without a murmur, and walking unshrinkingly through the fire of his destiny; than when enthroned in all the splendour that was designed for the decoration of the pseudo Emperor of the West; but the delusion is fled, and his own hands tore away the veil that dazzled us; and how ? not by preferring a complaint, altho' even complaint would, at one period of his life have astonished us; but by the nature and unworthiness of that complaint. There was we believe a day when the destructive frosts of Russia could not wring a grean from his proud heart; when want of even natural rest was held as a trifle; when even hunger, fatigue, and what was worse, when baffled hope could not force away one murmur, but " still undaunted, he endured and dared !" but now the great, unconquerable mind, that bore him towering above his fortune, has sunk under its own weight; and reduced him to the level of ordinary mortality.
