SAINT JOHN, Oct. 6.

(From the Courier.)

It has never, we may say, fallen to our lot since we have taken upon us the Editorial office, to record transactions more truly characteristic of the loyal feelings of our fellow-citizens than those demonstrated in this City during the present week, in commemoration of the Coronation of our Most Gracious Sovereign GEORGE THE FOURTH.—Expressive of the universal sentiment of joy felt by so respectable a body as the City and County Militia of St. John, a select Battalion was formed from this local force; who with a laudable zeal, having voluntarily offered their services on the occasion, were reviewed on Wednesday last, in conjunction with the Regular Troops in Garrison, on the Sands in the neighbourhood of the City, by His Excellency the Commander in Chief—His Majesty's Troops stand not in need of our praise; but we think it our duty to say that, when it is considered that our Militia, which have but so recently assumed a more regular and organized form than we have hitherto had an opportunity of observing, we never beheld a finer body of men; and the promptitude and order with which they performed several evolutions and manœuvres, exceeded our most sanguine expectations.

In honour of the day, a Ball was given by His Excellency the Lieutenant-Governor, which in splendour and magnificence far surpassed every thing of the kind we have witnessed on this side of the Atlantic. For the commemoration of so august a national festival, the Madras School Room was judiciously appropriated by the Trustees of that Institution. "From its arched roof, many a row of stary lamps and blazing crescents hung;" while the lofty and spacious walls were richly adorned with green boughs, the effect of which was relieved by the brilliant lustre of the resplendent arms and trophies which filled the several niches. Upwards of two hundred ladies and gentlemen were assembled in this noble Hall; and the whole afforded a coup d'oeil of elegance and taste not easily imagined.

The following day was also devoted to festivity; and being the anniversary of the landing of many of our forefathers for the first time on these shores, 38 years ago, may be deemed an era in the history of this Province, justly consecrated to patriotism and loyalty. That all ranks might participate in the general joy, three spacious tables were laid out in King's Square; and at one o'clock, an OX roasted whole, was conveyed to each, amid the shouts and acclamations of the populace, who regaled themselves at this plentiful board. Copious libations flowed in the mean time, and the whole terminated in peace, hilarity, and good humour.

In the Hall which shone the preceding evening with New-Brunswick's beauteous daughters, a table was laid and an entertainment furnished in a style which does great credit to Mr. Cody. The company was highly respectable. Dinner was served up at six o'clock; and nearly two hundred people sat down to table. His Excellency took the Chair, supported by His Worship the Mayor of the City and the Hon. General Coffin.

The cloth being removed, His Majesty's health was drank with the warmest enthusiasm, while a royal salute was fired in King's Square, and a brilliant display of Rockets exhibited at the same time. The grand national hymn of "God save the King," was sung by Mr. Chamberlain, accompanied by the fine band of the 74th Regiment, and a full and animated Chorus by all present. The following were the toasts given—

- 5th. The revered memory of our late King, George the Third.—*Dead March in Saul.*
- 6th. Church and State.—*Union March.*
- 7th. The United Kingdom—May she ever preserve her present exalted station among Nations.—*Roast Beef of Old England.*
- 8th. New-Brunswick and her Sister Colonies in North America—May they ever flourish under the powerful protection of the Parent State.—*New-Brunswick March.*
- 9th. The Fair Daughters of this Land.—*New-Brunswick Waltz.*
- 10th. The City of Saint John, and Prosperity to the Trade and Fisheries of British North America.—*City March.*
- 11th. The several Provincial Institutions for the Education of Youth—May the philanthropic and benevolent exertions of their Founders and Supporters, be ever remembered with gratitude by the rising generation.—*Hope thou Nurse of fond desire.*
- 12th. Success to the Institution which reared this Building; and may the fear of God, together with the loyal feelings which gave rise to our present Meeting, be ever inculcated within its Walls.—*All's Well.*
- 13th. The Militia of New-Brunswick—may it become our Bulwark in time of need.—*New-Brunswick Troop.*
- 14th. The Agricultural Society of New-Brunswick—May the industry of the Farmer be crowned with success.—*Speed the Plough.*
- 15th. The Duke of Wellington, the first Captain of the Age—*See the Conquering Hero comes.*
- 16th. The Governor in Chief, and the Army under his command in British North-America.—*Dal-housie's Grand March.*
- 17th. The Memory of William Pitt, and all Patriot Statesmen.—*Death of Wolfe.*
- 18th. The Memory of Nelson, Abercromby, and fallen Heroes of the British Nation.—*Major Andree's Farewell.*
- 19th. Britain's Glory—Ships, Colonies, and Commerce.

His Excellency honored the Company with his presence until a late hour. On his departure, Major Drury, Commandant of the St. John Militia, took the Chair, and gave the following toast, which was drank by the whole company standing, with a degree of rapture and delight, expressive of the highest respect and esteem—

"His Excellency Major General SMYTH, our virtuous and much respected Lieutenant-Governor—the impartial administrator of our Laws, the friend of the distressed, and the supporter of all our useful Institutions. Our thanks are due to him for having brought us together on this happy day"—*Three times three!!!*
The health of his Worship the Mayor of the City

was then drank; and several other popular toasts followed; among which, was the health of the Honourable General Coffin, who left the room amid the loud and reiterated plaudits of the company. While joy and universal harmony, reigned within; festivity and mirth were heard without. And, be it spoken to the praise of the vast concourse of the people assembled under the vaulted azure-sky, that they all retired in quietness to their respective abodes at a seasonable hour, and neither riot nor intemperance were seen in our streets; the entire day having been spent in a manner highly creditable to the good sense of this community.

We have also learnt that, at His Excellency's expense, a plentiful repast of Roast Beef and Plumb pudding, with a goblet of good liquor, was furnished by Mr. Nowlan, the Goaler, for such individuals under his protection who did not find it convenient to go abroad on this day.
