LATE FROM HAYTI.

A letter was yesterday received per brigger Packet, by a merchant here, from his correspondent in Cape Haytien, dated Jan. 28, 1821, which furnishes the following advices:—

" Gen. Richard, the Governor of the Cape who was so active in destroying Christophe's Government, has been detected in a conspiracy against the present government, has been sent, with several others, prisoners, to Port au Prince. In this instance, we think ourselves extremely fortunate to have escaped with our lives and property, as it is said, and generally believed, that had Richards succeeded, our property would have been plundered, and our lives endangered. Much dissatisfaction has existed, and still exists among the soldiers at the Cape, and they appeared to be ripe for any enterprize, where there is a prospect of plunder. As soon as the conspirators were arrested the soldiers commenced pillaging the property, and before they could be stopped cleared several stores of their goods and earried off all the effects of Richard's dwelling and office, among which was the Rolls of Equipage of all the vessels in the harbour. We were glad the American sloop of war Ontario, happened to come in the night before the uproar took place. The Amerieans and ourselves have petitioned Capt. Chauncey to stop a short time, and hope we shall feel more safe in a few days, but there are many ambitious and uneasy characters in this part of the country, and Heaven only knows what we may be doomed to suffer in this ill fated land, whose surface has been so often covered with ruin and blood.

INDIA.

Extract of a letter dated at Bombay, Au-

" We are picking a quarrel with the Emirs of Sinde. It is said, that our army of Dutch, under Sir Charles Colville, will take the field 16,000 strong, effective troops. The rains prevent the commencement of actual hostilities, and it probably will not be before October that the first blow will be struck. The Emirs of the Sinde are three brothers, Mahometans, said to be very warlike, powerful, and rich, not having ever been engaged in warfare with Europeans. The Sindeans are described as a very brave & athletic race of people, superior in their strength and stature to the Indians. We are not without fears that, at the period when this warfare commences, there may be a simultaneous breaking out in the districts of central India, under the command of Sir John Malcom, as many parts of them are by no means in a settled state."

We learn by the Levant, from Canton, that the Emperor of Chinea died in July last, as was stated in the last English paper; and that a difficulty existed in selecting his successor, there being two rival candidates for the throne.

AWFUL CATASTROPHE!—
With feelings of the most painful kind, we, this day, record one of those dreadful visitations of Providence to which the most prudent and cautions are liable, even when they imagine themselves most secure.—Two very respectable farmers, William and Andrew Mackey lately from Londonderry, Ireland, the former with a wife and five children, the latter with a wife and her parents, took a farm in November last from Mr. Dennison, 31 miles up the Kennebeckacis, in the parish of Norton. They lived together in a House two stories high, the upper part of which was not finished.

part of which was not finished. On Saturday the 10th inst, at half-past eight o'clock, Mrs. Andrew Mackey who had been delivered of a daughter the same day, at 12 o'clock, alarmed her husband and aged farther (Isaiah M'Lelland) who slept in the same room, calling out that the house was on fire. Instantly the men ran up stairs to see if they possibly could arrest the progress of the devouring element, but they could not remain there one minute and had only time to call to their wives and children to make their escape. The mother with her infant in her arms, which had come into the world only 8 hours before, ran out in her bed dress, without a shoe or stocking on her feet in the midst of drifting snow, and in that situation she found her way to the house of Mr. Dennison nearly a quarter of a mile distant. The husband and farther in the midst of the confusion and agitation, making every exertion to save what they could of their wearing apparel, &c. were not aware that she had made her escape, and rushed through the flames in search of her, when they were both dreadfully burnt, the former on the head and face, the latter on the back and hands. Mr. Wm. Mackey had alarmed all his family as soon as the fire was discovered and imagined that his wife, and two daughters who slept together, had all escaped, as the bed on which the girls lay, had been got out in safety, but, dreadful to relate, the youngest of the daughters, a fine promising girl 12 years of age, had perished in the flames! A little dog of which she was particularly fond was observed running about during the conflagration, and is supposed to have missed the girl and to have gone in search of her, as it was found lifeless beside the entrails of the unfortunate victim, which were all that remained to make known her awful fate. So rapid was the progress of the element that in the space of from three to five minutes after the fire was discovered no one could approach nearer than twenty or thirty yards of the house, and several boxes of valuable linens and other articles which had been got out, were consum-

ed before the door. In fact, not an article

was saved but the bed on which the two girls slept. Thus in the space of a few minutes, two families, consisting of ten surviving individuals have been plunged in the deepest distress, and reduced from a state of comparative affluence, ease, and comfort to the sad situation of being without a home, without an article of clothing, and without a sixpence to procure the necessaries of life.—As to the origin of the fire, nothing certain can be known. As the chimney had been burnt out during the day it is supposed that some embers may have lodged about the roof and communicated with some hay in the upper part of the house.

As an appeal is about being made to a genorous public in behalf of the unfortunate sufferers, we are requested to refer to the Rev. Dr. Bunns in favour of the character of Messrs. Mackey and families, and in evidence of the truth of what has been stated, to Capt. Thomas Clement, who was present at the scene.—Gazette 14th.
