This morning between the hours of one and two. an alarming fire broke out in the house of one Ferns, Lower Cove, which threatened most serious injury to the whole surrounding neighbourhood. Two dwelling houses, a tan-house, the property of Mr. Jehiel Partelow, Sen and a large quantity of bark belonging to Mr. A. Hart, were totally consumed The fire-brands were carried to an amazing distance over the Town, and had the wind been much stronger, it is impossible to calculate where the ravages would have ended. Happily, by the promptitude of the military and inhabitants in general, the conflagration terminated with the range of buildings where it originated, though the loss to Messrs. Partelow and Hart must be very considerable. There is too much reason to suspect that the fire was wilfully raised. -Star.

For some weeks past, extensive fires have been raging with extreme violence in the woods at Schooe ac, St. David, and Chamcook, and have even extended their ravages within two miles of St. Ancrews. On Thursday last, the town was completely enveloped in dense smoke, and showers of ashes and burnt leaves fell in all directions We have not been able yet to ascertain the precise a-

mount of damage occasioned by the fires in the County, but we believe it to be considerable. Mr Hopps, above Oak Point, has lost a house, and barn, containing 30 tons of hay; Mr. M. Thornton, house and bern; Mr. Carlow, a barn, and several head of cattle and some sheep, have fallen victims to the devouring element .--- Saint Andrews Herald.

LONDON, June 29. A great number of royal servants, with between 20 and 30 beautiful horses, will set out on Monday for Dublin, to be ready for his Majesty's reception. The Duke of Devonshire, with a princely retinue, accompanies his Majesty

Russia. - In this empire, public opinion is said to declare itself more strongly in favour of the cause of the Greeks. To the sympathy excited by a community of religious faith, has been added a deep sentiment of indignation at the atrocities of the Turks.

The British Monitor says-" The Russian army in Bessarabia, under the command of General Witgenstein, amounting to 70 000 men, had received orders to cross the Danube, and to proceed to Constantinople, and that the Russian fleet in the Black Sea, with troops on board, is at the same time to make an attack on the Turkish capital. It will require three weeks ere the army of Bessarabia will be able to reach Constantinople."

KINGSTON, (Jam.) July 10. A fire took place, April 10, at the town of Omen, Bay of Honduras, when 250 houses were consumed, and only 18 left standing.

The boats of the Lady Wellington packet will attend to receive specie for England until the 16th curr.

Upwards of 50 houses were destroyed by fire June 10, at Bridgetown Barb.
