The English Mail that reached this place yesterday, arrived at Halifax from Falmouth in 20 days-London dates to the 16th ultimo.

On the 21st of May a vote of £100,000 was agreed to in the House of Commons, towards the expence of the Coronation.

We publish this day a Royal Proclamation, bearing date the 5th day of June 1821, which fixes the Coronation for the 19th July inst.

THOMAS HATTON, a Soldier of the 74th Regt. died on Friday evening last, on his return from work. An Inquest was taken the day following, before WILLIAM TAYLOR, Esq. Coroner for the County of York, and a verdict returned -Died of Apoplexy.

We learn from Miramichi, that the fire which raged in the Forest of that place about three weeks since, communicated to the property of Mr. THO-MAS SMITH, and consumed the dwelling House, Barn, several small out-houses, and his Mills on Sabbies River, with 80,000 feet of boards, a number of saw logs, &c .- The whole amount of loss is estimated at about £1800. We understand that he had £1200 of the above insured.

COMMUNICATED.

THE ANNUAL REPORT of the WES-LEVAN METHODIST MISSIONARY Society for 1820, lately received 'from Europe, contains highly interesting details as to the indefatigable exertions of that respectable body of Christians, in the promotion of Christian Knowledge.—The Society employs in Ireland, eleven Missionaries, (who use the Irish language); in Gibraltar, one, and in France, five; in western Africa, four; in southern Africa, seven, with an Assistant, a Hottentot convert ;---in Bombay, two; on the Peninsula of Hindosian, four, and in the island of Ceylon, fourteen, with three Assistants, persons of highly respectable connexions, country born, but converted under the Ministry of the Missionaries; in New South Wales, four; Vandiemans Land, one; in New-Zealand, two, and in the Friendly Islands, one;---in the West India Colonies, forty-four; in Canada, ten; in Nova Scotia and New-Brunswick, nineteen; and in Newfoundland, twelve:---making a total of 141 Missionaries and three Assistants. The number of Members in the Societies under the care of these Missionaries appears to be 27.452. Upon most of the stations occupied by the Missionaries, are schools connected with the Missions, and in Ceylon alone the Mission-Schools contain 4008 children, many of whom are females.

In Ceylon there are three printing presses connected with the Mission, and which in connexion with the Government Printing press under the superintendence of the Missionaries in Colombo, are employed in issuing for the use of the Schools various elementary works, the Liturgy of the Church England translated by the Brethern of the Mission into the low country Portuguese, the Tamul and Cingalese, and the Cingalese and Sanscrit Bible for the Colomon Bible Society, for general distribution.

The net receipts of the Society in Sub-

scriptions, donations and legacies, from June 24, 1819 to Dec. 21, 1820, amounted to £30,803: 3: 4, and the disbursements to £34,993: 11: 5.
