Nothing particularly important had recently taken place in Chili. News had been received from Peru to the close of Feb. at which time Gen. San Martin remained about Huanra, 80 miles from Lima, with an army of from 7000 to 8000 men.

The Spanish force was at Lima and consisted of about the same number. A general engagement was not anticipated, but it was believed that the expedition from Chili would be ultimately successful. The Vice Roy Peruelas had been deposed by the military, and Gen. La Serna was appointed in his stead. The Chilian squadron continued off Callao.

We have seen a letter from Rio Janeiro 28th April, which says--" His Majesty the King left here for Lisbon on the 28th, and all the Royal family accompanied him except the Prince, who is to remain. A meeting of the inhabitants, for political purposes has been held in the Exchange; but it appears the object of it was not satisfactory to the Royal authority, and the people were compelled to disperse---Order, however was soon after restored, and all was quiet 12th May, the date of the latest advices.



10TH JULY, 1821.

We have selected for this day's publication, from the Halifax papers by the last mail, London intelligence to the 25th of May inclusive, nine days later than was furnished by the English mail for that month.

Accounts from Paris of May 20, state the news from Madrid to be very alarming —Insurrections having broken out in Murcia, in which a number of people (about 50.) were said to have lost their lives. The King was about to leave Madrid, and retire to Toledo, or some other place of greater security.

Erom the London Shipping List, May 12. The Earl of Buckinghamshire, from Greenock to Quebec, with near 600 passengers on board, ran on shore near Bray Head, Ireland, during a fog, on 2nd inst. but was got off the next tide, by assistance of the officers of the customs and the preventive service, with loss of an anchor and cable.

Rear Admiral Griffith, we understand, intends visiting the Falls of Niagara.—Lt. Col. Gauntlett, and Deputy-Commissary General Haden, who have gone in the Newcastle, will accompany him thither.—Halifax Journal.

WILLIAM F. ODELL, Esq. Secretary of the Province, arrived here on Friday last from Boston.

Boston, June 15 .-- After a session of nearly four weeks, the Commissioners under the 5th article of the Treaty of Ghent, adjourned on Saturday last, to meet again in this city in the beginning of August. Opening arguments were made upon the several points submitted to the Commissioners, by Mr. Bradley, of Vermont, on the part of the United States, and by Mr. Chipman, of New-Brunswick, on the part of Great-Britain. It is expected that at the next meeting, the Agents will reply to each other, and that the Commissioners will then, or soon after, come to a definite decision, or report their disagreement to their respective governments .-- N. Y. Columbian.

From the Acadian Recorder. The Grand Canal in the state of New-York is advancing with great rapidity towards the Hudson. It is within a few miles of Schenectady, and the Albany Gazette promises that it will shortly extend to that city. Nothing will counteract the pernicious effects of this vast and spirited enterprize upon the exports of Canada, but a zealous improvement of the internal navigation of that country. We are happy to observe that bills have passed the legislature both in the Upper and Lower Province toward the prosecution of this grand object. A very trifling expence compared with the resources of the country and not exceeding £200.000 in all would completely do away with the present obstacles, and open up a clear, uninterrupted navigation from the upper Lakes to Quebec. The Canal of ten miles from La Chine Montreal to avoid the falls of Saint Louis is in progress; and we hope that the others which are projected will be conducted during the summer with a successful and vigorous perseverance.

The Am. ship Essex, Pollard, in the Pacific ocean, was struck by a whale, and sunk soon after. The crew left her in 3 boats, 2 of which have not since been heardof---the 3d with the master and a boy only on board -- their comrades having perished, or been put to death by lot to appeare the hunger of the survivors, was fallen in with by the ships Diana and Dauphin, taken up, having passed ninety days in a state of such indescribable horror. Brig Tom Hazard, Purce, from Bristol, England for Newport, foundered May 10 --- Passengers and crew, 17 in number, were taken up after being 3 days on the ocean in the brig's boat, by ship Lucy, bound for Liverpool, England.
