recommend such as they consider expedient to cancel, and that those remaining should be sent to the Sessions in the different Counties, to be paid by labour on the Roads; and that the House of Assembly do address His Excellency the Lieutenant-Governor, on the subject.

Mr. M^cKay, presented a Petition of Charles R. Hatheway, praying remuneration for services performed by him as Gauger of dutiable articles in the Parish of West Isles, in the year 1819.

Friday, 9th February.

Mr. Fraser, presented a Petition of the Emigrant Society, praying further aid towards the support of that Institution, and Mr. Stubs, a Petition of the Overseers of the Poor for the Parish of Saint Andrews, praying remuneration for money expended by them for the maintenance of several Emigrants in that Parish. Which were referred to the Committee of Supply.

A bill, " to repeal the Laws now in force for regulating Pilots, and to make further regulations relating to the same," and a bill, " for the better extinguishing Fires which may happen in the Towns of Fredericton and St. Andrews," were read a second time. Mr. M. Kay, presented a Petition of Robert Ludgate, a settler on the Great Road between St. Andrews and St. John, praying pecuniary aid --- referred to the Committee of Supply. Mr. Simonds, from the Committee appointed to inquire and report, what sums of money heretofore granted, remain unpaid, and what will be the disposable funds of the Province, which have arisen, or are likely to arise, from the Revenue in the course of the current year, reported, 1st, That of the sum of £3000, granted in the year 1819, for Bounties on Fish, only £1155 has been paid by the Treasurer. The amount of this grant that remains unpaid, will be £184 0 0 2d, That of the sum of £1000, granted the same year for Bounties on Grain raised in the Province, £57,4 17 8 have been paid. Of this grant the balance unpaid is 425 2 4 3d, That sums were granted in the years 1819 and 1820, for the encouragement of Schools, amounting to £5790, of which sums only £3090, have been paid: which leaves of this grant unpaid 2703 0 0 4th, That £5000 were granted in 1820, for the improvement of the Bye Roads throughout the Province : the whole of which sum is unpaid 5000 0.0 5th, That of £5000 granted the same year for the improvement of the Great Roads, £1882 appears to have been paid : which leaves of this grant unpaid, the sum of 3118 0 0 6th, That no part of the sum granted for the improvement of the Navigation of the Rivers in this Province, in 1820, amounting to £1150, has yet been paid. 1150 Ò 7th, That the whole of the sum of £3000, granted last year for Bounties on Fish, yet remains unpaid. 3000 0 8th, That there still remains in the hands of the Treasurer, to be cancelled, Notes to the amount of 612 10 0 9th, That the amount of drawbacks due for merchandise exported out of the Pro-Vince, is 3000 0 0 1 oth, That the sums borrowed by the Province Treasuter, agreeable to an Act passed in 1819, authorizing him to borrow the sum of £9000, to pay the demands on the

These several sums amount to the sum of £23,732 14 4; which exceeds the whole amount of balance in the Chest, by £121 16 0; and consequently there are no disposable funds in the Treasury.

In this report, no notice is taken of the balances in the hands of any of the Deputy Treasurers, nor is any notice taken of bonds in the hands of the Attorney General for collection.

As the time when those balances will be paid, and when the said bonds will he recovered, is very uncertain, they cannot, in the opinion of your Committee, in any way affect the disposable funds of the Province for the current year.

Your Committee beg leave particularly to remark, that of the balance now in the Chest in Bonds and Notes, the sum of £7000, will not be due until the year 1822.

And they further suggest the probability, that the balance unpaid of the grant for Bounties on Fish, for the year 1819, will not be applied All which your Committee respectfully submits to the attentive consideration of this Honourable House. The House resolved itself into a committee of the whole House, on the further consideration of a bill, " to prohibit Foreigners selling by retail in the Port of Saint John." Mr. Agnew chairman of the Committee reported the Bill agreed to, which was ordered to be engrossed. On motion of Mr. Smith, Resolved that an humble Address be presented to His Excellency the Lieutenant-Governor, praying that he will be pleased to inform the House of Assembly, if any and what steps have been taken for the recovery from T. Price, Esq. and his Sureties, the amount of their bonds for duties on rum, amounting to £1018 14. Mr. Simonds brought in a bill, " to amend the Laws now in force relating to trespasses, and to make further regulations to prevent the same." Which was read a first and second time and ordered to be committed on the 13th. Mr. Campbell brought in a bill, " to authorise the Justices of the Peace for the County of Charlotte, to levy an assessment to pay off the County debt." Which was read the first and second time and ordered to be committed on Wednesday next. On motion, ordered that the Petitions of Henry Smith, Esquire, and Benjamin Atherton, complaining of an undue return for the County of York, be now read.

To Thomas Bonnor, Esq. the sum of £100 sterling, for his services, as Agent for the Province, for the year 1820. To His Excellency the Lieutenant-Governor or Commander in Chief, for defraying the contingent expenses of the Province, a sum not exceeding £250, for the year 1821. was not given as entered in the Poll Book, at any election, and to report thereon to the House---reported that they have made search in the Journals of the House of Commons in England, and find,

That in the Bedford case, in the year 1715, the question being put, whether The Counsel for the sitting Member be admitted to examine Edward Kemp, to prove that William Reynolds voted other. wise than he is set down upon the Sheriff's Poll, it passed in the negative."

That in the Southwark case, in the year 1735, the question being put, "That de Counsel for the Petitioner be admitted to esamine persons who voted at the last election of Members to serve in Parliament for the Borough of Southwark, to prove that they voted otherwise than they were set down to do upon the Bailiff's Poll," it passed in the negative nemine contradicente.

"That in the Oxford case, in the year 1755, the question being put, that Counsel be admitted to produce one of the Check Books kept by an Inspector of the Poll, together with parole evidence, in order to prove that one of the electors voted for a freehold lying different from that which is entered in the original Poll Book, and that the said elector then declared the freehold for which he voted, to be in the occupation of a differefft person from that which is also entered in the Poll Book, the House divided, and it passed in the negative. The Committee also find it stated in a late treatise on the law and practice of election, that in the Bedford case, before a Committee of the House of Commons, in the year 1784, a question arose as to the admissibility of evidence to shew the Poll Clerk's mistake in having put down one vote for the sitting member, which in fact was given to the Petitioner ; and the Check Books of each Candi. date's inspector agreeing together and corres-" ponding with parole evidence of the fact, in contradiction to the Clerk's Poll Book; and it appearing also in evidence, that ap= plication had been made during the Poll to rectify the mistake, which the Sheriff had declined doing, the Committee held that the Book ought to have been rectified,' and that the Petitioner should have been returned, and the return was amended accordingly. But in the same case where there had been a mistake, as was alleged, in the taking down of another vote, the Inspector's book agreeing with the Poll Book, and no application traving been made expressly during the Poll to rectify the mistake, the Committee would not let in such evidence. In the same case, the return being amended upon the decision of the tirst Committee, by substituting Lord Ongley instead of Mr. St. John; on the return this question was again agitated, and the Committee received parole evidence, that Ayres the voter, had voted for Lord Ossory and Mr. St. John, though his vote was taken down by the Poll Clerk for Lord Ossory only. The Voter himself, after other parole evidence, was admitted to prove how he had given his voie, though by the former Committee he had been rejected. Both Check Books in this case confirmed the Poll Book. In the same Committee a resolution being proposed, " That the Counsel be admitted to produce evidence tocorrect mistakes upon the Poll Book, altho' no such evidence was tendered to the Sheriff," either at the time of election, or as soon after as it was discovered, it passed in the negative. The above are all the cases in point which the Committee have met with in the Books to which they have had access, and are respectfully submitted to the House.

Which having been read --- On motion of Mr. Chipman, Resolved that a Committee be appointed to search for precedents, as to the propriety of admitting evidence before the House, to shew that the vote of any Elector was not given as entered in the Poll Book, at any election, and to report thereon to the House. Mr. Chipman, Mr. Wetmore, Mr. M. Kay, Mr. Peters, and Mr. Miles, were appointed a Committee for that purpose. Mr. Campbell obtained leave to bring in a bill, "to revive and continue an Act passed in the 50th year of the Reign of King George the Third, intituled " An Act for the preservation of Moose on the Island of Grand Manan." The House then adjourned till seven o'clock. The House met pursuant to adjournment, and resolved itself into a Committee of the whole House, upon a bill " for the better extinguishing Fires that may happen in the Towns of Fredericton and St. Andrews." Mr. Ritchie, chairman of the committee, reported the bill agreed to, which was ordered to be engrossed. The House again resolved itself into a committee of the whole House, on a bill, " to repeal the Laws now in force for regulating Pilots, and to make further regulations relating to the same." Mr. Clarke, brought in a bill, " to amend an Act, intituled " An Act against the Profanation of the Lord's day, commonly called Sunday, and for the suppression of Immorality." Which was read the first time.

To the Adjutants of the Militia of the different Counties in this Province, a sum not exceeding £120, for the year 1821, agreeably to a Law of the Province.
