LONDON, JULY 23.

The late Abel Worth, Esq. who died a few days ago at his season Devonshire, has bequeathed £3000 to the Episcopal School for boys at Exeter; £3000 to the same establishment for girls; £3000 to the School of St. John's Hospital in that city; and a handsome legacy to the Devou and Exeter Hospital. A pier of suspension, on the same principle as the

iron bar bridge over the river I weed, is completing from Newhaven, near Edinburgh, which is to extend seven hundred feet into the sea, and will admit of vessels coming alongside it at low water.

Lodging in Dublin have risen full 50 per cent. since it was known that his Majesty would visit the capital of Ireland, and a Royal Box is preparing in the Theatre, under the impression that his Majesty will honour it with his presence during his stay there.

JUNE 27. The King of Sweden has again remonstrated with the Norwegian Diet on its resolution for abolishing the Nobility, whence he says the utmost danger will arise, unless some other monarchial institution

is established in the place of it. A letter from Smyrna says, that those infernal wretches the Turks have driven Professor Ramban, (a most excellent man) from Scio, and broken up his establishment for 500 boys; and they have also broken up the school upon the British system at Smyrna, which was formed after the benevolent W. Allen left Smyrna, for 150 boys. May this triumph of ignorance be only temporary!

A letter from Cape Coast Castle of the 27th March mentions, that the process of vaccine inocculation has been introduced among the natives of that part of Africa with considerable success, affording the prospect of ameliorating the most dreadful scourge with which the black population is afflicted

-except the slave trade. Attempted Suicide. - A respectable Clergyman who for some years has resided on his small living in the eastern part of Kent, from unfortunate circumstances has lately got involved in debt through a law suit, and in consequence, on Thursday last sent to the County Prison, Maidstone, and placed on the debtors' side. His wife and daughter visited him on Saturday week; the interview was highly affecting; their anguish at parting, and the idea of his being incarcerated in a prison, appeared to have had such an effect on his feelings, that he on Monday morning endeavoured to deprive himself of life. It appears he obtained a razor from a dressing-box of a fellow debtor, with which he made an incision on his wrist, but this appearing not to have the desired effect, he afterwards made a dreadful gash in the bend of his arm, which nearly severed it, and he was found weltering in his blood, and almost lifeless Medical assistance was promptly procured, and the bleeding stopped; but there are but faint hopes entertained of his recovery

Hanover, June 22 .- One of the preparations making for the reception of the King, is the demolition and re-construction of the town gate, which opens on the road to Harenhausen, over which a grand triumphal arch, embellished with trophies, is erecting It will henceforth be called the Waterloo gate The King will be the first who will pass under it; until which, it is notified that the passage is prohibited. The expense is estimated at 8000

Chambray, June 30 - For several days past a report has been in circulation in this province that the King will not come to Piedmont, and that a part of the kingdom is to be subjected to the Austrian government. This rumour, spreading amongst all classes of the inhabitants, and particularly among the troops of the brave regiment of Savoy, has caused a general feeling of discontent in that corps, which their arms and baggage.

This plan was to have been put in execution after rejoicings for the celebration of the festival of St. John; but the Governor and the other Authorities of the city who had information of it, took such measures as defeated the plot on that very day. Subalterns and soldiers to the number of 60 have been arrested and conducted to the citadel, where they will be interrogated Government entertains the expectation of being able to discover the leaders by the declarations of the soldiers under arrest.

Not withstanding these arrests the discontent continues. The presence of the Austrian troops in Piedmont for an indefinite period seems to be the cause of it. It is well known that the keys of Alessandria have been sent to King Charles Felix, but the Austrians are not the less masters of that rampart of Picdmont. There has been talk of a number of evacuations which were to take place there, in consequence of the sentences of the military com-

Yesterday, at 12 o'clock, the Duke of Wellington, Viscount Palmerston, Sir Charles Long, Mr. Huskisson, and other official Gentlemen, assembled at the Chancellor of the Exchequer's house The object of the assembly was to make arrangements for the reduction of expenses in their different de-

The delay in not inserting the names of the new Peers in the Gazette, is said to arise from some dissatisfaction which has taken place either in Ireland, or amongst the Irish Nobility in London, occasioned by certain exclusions. Rumour goes so far as to hint that promises have not been most rigidly kept. - Morn. Chron.

The weight of sovereigns and half sovereigns sent by the Bank of England to Manchester, was nearly four tons, for the purpose of exchanging gold for paper; this being effected on Saturday last, to the amount of £419,600, the office was closed.

Lisbon, June 12. -On Sunday the 10th at 5 0'clock in the afternoon, a fire broke out in a part of the square where the palace of the Junta of commerce is situated. No public misfortune since the earthquake of 1755, has equalled this; all attempts to stop the flames were useless, and it destroyed almost the whole of the palace in a short time. There is no doubt but that the fire was by design, as pitch and other inflamable matter were found in the neighbourhood The damage is incalculate The five depots of acts the most important to the nation have been destroyed. Mr Sepulveda took, though uselessly, the wisest measures to stop the flames; and the commander of an English frigate in the port, sent engines and the greatest part of the crew A great number of military have suffered from their courage: an officer of the English navy and two sailors have been dangerously wounded.

BOSTON, AUGUST 25.

The schooner Abigail arrived here late last evening in 17 days from Curacoa, by which we learn from Capt Johnson, that the fleet from Spain, consisting of nine sail, on board of which was the new Viceroy, had arrived at Porto Cabello; but that, on learning the disastrous state of affairs, in consequence of the successful progress of the Patriots, his Viceroyship considered it prudent, after taking a considerable part of the garrison on board, with their equipments, to direct his course first to Curacoa, and thereafter to Kingston, Jamaica, where he intends remaining for the present. The patriot army had not been idle after taking possession of Caraccas. With that promptness which is so characteristic of Bolivar, he marched upon Porto Cabello, which after driving in the out posts, he closely invested, and pressed with so much vigour, that no doubt remained of the Royalists being speedily compelled to surrender the place. The Patriots were already in possession of the whole of the suburbs, the finest and most populous part of Porto Cabello Several skirmishes had taken place, and many houses had been destroyed. As the Hippomenes was to sail in four days after the Abigail, it cannot be long before we receive more enlarged particulars of those interesting occurrences, and of the events subsequent to her departure. - N. York Advocate.

Extract of a letter from St. John's, Porto Rico, dated 2d inst. to a house in this city.

" A dangerous plot was discovered on the 24th ultimo, the day previous to its intended execution, amongst the slaves in this quarter of the island. Their plans were laid with much cunning, and the most profound secrecy, and every preparation in their power made for an extensive insurrection, on the night of the 25th. The conspiracy, as far as it is yet discovered, extends through several of the most considerable districts, but it is believed to be much more general. Many of the chiefs are already taken, and their trial and execution will be very summary. From the measures taken by the Governor, who is a vigilant and excellent officer, to detect the remaining ringleaders, and secure the general tranquillity, nothing further is to be apprehended."

BERMUDA. AUGUST 4. One of the most extraordinary transactions has been going on this present week, that has ever been witnessed in this insulted and degraded country; and though consumately farcical in its results, it has been attended in its progress with circumstances of too serious a character to be slightingly passed

The transaction we allude to, is briefly this: -On the night of the 26th July, Mr. John Till, the Mayor of St George's, having received information of their being an assembly of negroes at a grog-shop was carried so far that the soldiers had formed the in the Town, dancing and carousing beyond the design of returning altogether to their homes with time of night allowed by the ordinances of the Corporation, proceeded there, accompanied by another person, for the p rpose of dispersing them. On his arriving there, the negroes, at his request, / which seems to have been moderately and inoffensively expressed,) quietly broke up their dancing and retired On his retiring from thence, information was afforded him of their being some other meetings of the same sort. To the places where they were represented to be, he also repaired; and ar one, finding a fidling and carousing, he accordingly dispersed the meeting.
