with a black silk handkerchief, and a seal skin travelling cap .-- Assisted by Mr. Mi-Dowell and two Revenue Officers, nearest the spor, he ascended the companion ladder, and put his foot ashore in Ireland ! A lane was made through the immense crowd of people, and, amidst reiterated cheers, he took his seat in the carriage .-- The King held out both his hands, with considerable humour; and a cordial shake was substituted for the court etiquette of kissing the hand of the Sovereign. A signal gun on the hill was the only indication that the King had touched the Irish shore. Admiral Rowley in the Cyrus, with the pleasure boats, cruizers, &c. immediately got under way; but, as the King had landed, the flotilla sailed back again. The King drove off, leaving behind him the whole of his suite; and the mail coach was detained for Lord Londonderry, who stepped ashore from the same packet, out of which the Sovereign had landed .--- His Majesty alighted at the Lodge, and was received on the steps, by His Excellency the Lord Lieutenant, and the Official Personages at the Castle. The shouts were here reiterated; when his Majesty addressed the people, thanking them for their affection, and assuring them he should have the satisfaction of drinking their healths, and those of all his good People of Ireland in a Glass of Whisky Punch. Night closed upon the universal exultation, and the King dined with a select party at the Lodge.

HALIFAX, SEPT. 18.

Yesterday morning about two o'clock the inhabitants of this town were alarmed by the cry of Fire, when it was ascertained that a building opposite the Chocolate Manufactory was in flames; which extended with such rapidity, that at the dawn of day twenty-three houses were destroyed. They were owned as follows: Estate of the late A. Bremner, 3; Mrs. Liswell, C. R. Fairbanks, Esq. Mr. C. Carver, Mr. M. Bennet, Mrs. Miller, Mrs. Whitecross, Mrs. Clacus, Mr Cullimore, Mr. G. Hurst, Mr. Craigen, Mrs. Willis, 1 each; Mr. Townshend, 2; Mr. Cassedy, Mr. Pollard, Mrs. Izat; Mrs. Neilson; 1 pulled down, and 1 materially injured; Jack Etter, a black man, 1. Fortunately the weather was moderate, and the devastating element was confined to the block in which it originally appeared.

The fire originated in a Bake-House, and we understand was caused by a quantity of wood, which had been placed in an oven for the purpose of drying, and having been taken from thence and laid on the floor, caught fire and communicated to the building. Happily no lives were lost, altho' several

persons were materially hurt. To the Army and Navy, the inhabitants of Halifax are greatly indebted for their exertions in stopping the ravages of the flames. His Excellency the Lieut Governor was present, encouraging and directing those about him; the Field Officers and the Officers of the Garrison, and the Captains of His Majesty's ships in the harbour, with the troops and seamen under their command, were uncommonly active. Where all seemed to feel and act so well, it 'may appear improper to mention individuals, but we cannot refrain from expressing our admiration of the conduct of Colonel Sir Robert Le Poer Trench, of the 74th Regt. whose endeavours to save furniture and other articles in the houses which were subsequently consumed, were conspicuous and succesful. Captain Napier with four seamen, contributed in a great measure in preventing the extension of the calamity; they placed themselves on the nidge of a house next to the last which was consumed, and by means of poles compelled the end of it to fail inwards; this service was performed at the risk of their lives, as had the blazing timbers fallen in a contrary direction, they must have been crushed by the descending ruins.

We would willingly stop here; - but we feel it our duty to state, and we do it with shame and sorrow, that numbers of the inhabitants stood by indifferent spectators of the havoc which was around them; and every attempt was unavailing to induce them to act like men. This evil demands an increase of Fire Wardens, and were twenty persons selected from each of the different Fire Companies to act as Special Constables and assist the Fire Wardens, such disgraceful conduct would be prevented, the idle and refractory would be compelled to do their duty, and the property of the sufferers would be more effectually secured. - Free Press.
