The regular trading ship Hercules, arrived at this port yesterday, in 42 days from Liverpeol. By this arrival the Editors of the Commercial Advertiser have received from their Correspondent, London papers and Lloyd's Llsts to the 19th January inclusive.

We have looked the papers carefully through; but have been able to find nothing of much importance. We have made a few selections of the most interesting items.

From the complexion of the Papers, we should judge that tranquillity is pretty generally restored. A few meetings have been held since our last advices, both by the friends of the Queen and the loyalists, but the proceedings are quite languid in comparison to what they were a few months since.

Parliament was to re assemble on the 22d of Jan. and it will depend upon what further measures are proposed by the Ministry, in relation to the affairs of the Queen whether the Public mind will again be seriously agitated upon this subject. The next arrivals will probably furnish us with matter of more interest than the present.

To flis Excellency the Lieutenant-Governor or Commander in Chief, the sum of Lioo sterling, towards procuring the full sized Portrait of His late Majesty, pursuant to the resolution of the House of Assembly of the 1st of February. -

A London paper of the 18th of Jan, says : That after a long discussion in the Cabinet Council, the Earl of Liverpool and Lord Castlereagh set off together to Brighton to lay the results before His Majesty. The matter probably alludes to the course which they desire to pursue on the meeting of the two Houses, and upon which they are to take the King's pleasure. The rumour in the Political circles is, that the Speech from the Throne is to be extremely moderate; that a proposition is to be submitted to the Commons to fix the Queen's establishment at £50,000 a year, the sum offered at St. Omer's, and that Ministers are to stand or fall on the question of the restoration of Her Majesty's name to the Li-

turgy. Upon this point they carculate on a majority of seventy, which, in the House of Commons, is less than a majority of nine in the House of Lords.

It would seem from the purchase by the Queen of Mariborough House, that she has determined not to leave the Kingdom, whatever measures may be fixed upon by the Ministers.

Fresh rumours are set afloat every few days, of changes about to take place in the Ministry, but they are all probably without foundation. It is likely true that Ministers tendered their resignations immediately after the failure of the Bill of Pains and Penalties; but were prevailed on by the King to remain. It is now said, that should the arrengement which they mean to propose for the Queen, on the meeting of Parliament, not meet the support of a decided majority of the House of Commons, they are determined to remain no longer in office. Considerable attention is directed to the affairs of the Continent, and the anticipated d liberations of the Congress at Laybach. Lord Gordon will represent the British government at that Congress.
