Papers from St. John, received since our last, contain London dates to the 23d of June, extracts from them will be found in this day's Gazette.

A Bill has been twice read in the House of Commons to allow the exportation of Sheep to the British Colonies, and a Bill for a Loan of thirteen Millions sterling, for redeeming the public debt has been twice read.

The promotion in the army, or the coronation of his Majesty, it is reported, will be down to Major General Sir Wm. Cockburn, bart. to the rank of Lieut. Generals: and down to Colonel Jasper Nicholls, to the rank of Major Generals.

LONDON, JUNE 10.

American Loyalists.—A long discussion took place in the House of Commons on Wednesday, on a proposition of Mr. Courtenay, for granting a compensation to American Loyalists. This subject has been so frequently debated, that no new arguments were brought forward. Mr. Vansittart opposed it, on the ground that the public could not afford to appropriate 130,000£ to this purpose. The Right Hon. Gentleman, however, found a strong argument against him in the simple argument of Aye and No; for, on a division, the numbers appeared—

For the Motion, 77
Against it, 60
The claims of these unfortunate individuals, it is understood, will now, after a lapse of forty years, be submitted to a Committee to decide on their justice.

From the Halifax Free Press, 7th Aug. The New-Brunswick Star received by the Mail, contains accounts from Bermuda to the 18th ult. by which it appears that the Governor of that Island has been faithful to his promise, and has actually committed the Church Wardens of the parish of St. George to the county gaol. His Excellency, it seems, called a court of Magistrates, and assembled them in the Vestry with closed doors, where he cited the Church Wardens to attend; they refused to do, in consequence of legal advice which they had obtained. A guard of soldiers was then dispatched with a constable, and those gentlemen were brought before this strange tribunal. The Governor then stated that if they did not give up their papers and monies, he would commit them to jail where no power on earth could relieve them. They stated in reply that they had experienced much difficulty in collecting the sums that were due to the Parish, for two years assessments: and declared that they would not give up their accounts till the time granted by the Vestry had expired: some further discussion then took place, and His Excellency produced a mittimus, which he had brought with him and COMMITTED THE CHURCH WARDENS OF THE PARISH OF ST. GEORGE TO PRISON, UNDER A MILITARY ESCORT!!!

SAINT JOHN, AUGUST 8.

The Annual Meeting of the Children of the Madras and other Schools in this City, took place last Wednesday, 1st August, in Trinity Church, agreeably in public notice, when an appropriate and excellent Sermon was preached by the Rev. JEROME ALLEY, Rector of St. Andrews, and a collection made for the benefit of the Institution amounting to £34:0:8.

The Children occupied the galleries of the Church, which were reserved for their accommodation; and from the estimate that was taken by the Church Wardens, it was found that the number present exceeded 750.

We never observed so many Clergymen of the established Church present on any former occasion. The congregation was large and most respectable. The Music, which was performed by a full choir, was uncommonly fine.

The whole presented a scene of a nature the most gratifying and interesting to every philanthropic heart.—COURIER

The Grand Jury have appropriated their fines, amounting to £2:3:9, to the benefit of the African School.

A Special Court of Oyer and Terminer and Gaol Delivery, was opened in this City, on Tuesday the 31st ult. and closed on the Thursday night following. His Honor Judge BLISS presided. In order to deliver the Gaol it was, it appears, necessary to prefer twelve Indictments to the Grand Jury—nine of which were returned true Bills, and the remaining three were not found. Of those found, one was for Petit Treason, another for Burglary, three for Grand Larceny, two for Petit Larceny, one for an Assault with an intent to commit a detestable crime, and one for an Assault and Battery.

Petit Treason.—The case of Petit Treason, we believe, the first of the kind in the Province. AILEY CARY was charged with the murder of her husband Patrick Cary; and although she was found not guilty—the evidence being, we presume, in the opinion of the Jury, defective, there is too much reason to believe she was guilty of the crime. Burglary.—John LANEY, otherwise Lindsay, Private in the 74th Regt. was charged with breaking and entering the shop of JAMES CARL, and

stealing money and other articles. He was acquitted of the capital Felony, but found guilty of the Larceny: it being doubtful, or rather not sufficiently certain, whether the House was broken before or after day-light.

GRAND LARCENY.—Michael Barlow, was convicted of stealing a pair of boots from RICHARD SMITH, and sentenced to receive 40 lashes and one week's imprisonment.

John Coats and Henry Phillips, were charged with stealing about £96 in money, from JANE HUDSON. Coats was convicted and sentenced to receive 40 lashes and three months imprisonment. Phillips was acquitted, but there is too much reason to believe merely from defective evidence.

John Sullivan was charged with stealing a watch, a pair of shoes and other articles, from JOSHUA B WILLIAMS. The evidence not being sufficiently certain as to the watch, he was convicted of Petit Larceny only, and sentenced to receive 40 lashes and one week's imprisonment.

Petit Larceny.—Patrick Scally, was charged with stealing a jacket and waistcoat from JOHN REED, and acquitted.

Robert Matthews, was charged with stealing a parcel containing 55. in coppers, from KINNEAR & PIGEON, and found guilty: but recommended by the Jury to mercy: and sentenced to one month's imprisonment.

OTHER OFFENCES.—James Smith, was convicted of the Assault with intent to commit a crime, which we shall not name, for which he was sentenced to stand one hour in the Pillory.

The Assault and Battery was too trifling to be further noticed.

The Court adjourned at about ten o'clock, and the Judge left town the next morning in the Steam Boat for Fredericton.
