## BOSTON, FEBRUARY 14. BONAPARTE.

By passengers in a ship which arrived a New-York, from Calcutta, the following information has been received.

November 4th, stopped at St. Heiena; was boarded by a lieutenant of the flag ship, who inquired what we needed, and said that the water of which we requested a supply, should be sent off immediately.

We learned from the officers who boarded us, that nothing new of any interest had taken place with regard to NAPOLEON BONAPARTE .- He persists in keeping himself entirely secluded from every one, excepting those of his own family : and notwithstanding he has liberty to recreate to the extent of a number of miles in and about Longwood, yet, as he must in such case be accompanied by an English resident, (the present one for this purpose is a captain of the army,) and as he would be exposed to the gaze of the inhabitants, to whom his ap. pearance would be as great a novelty as on the first day of his arrival, he chooses to forego the pleasure and the walls of the gar. den, and grounds immediately connected with his house, bound his promenades. Gen. Bertrand and his lady were still with him. No foreign officer remains at present to hold surveillance but a French nobleman, the Russian and Austrian Ministers having return. ed some time since. Bonaparte has not consented to see a single person, since Lord Amherst was admitted to an audience-and it was supposed that it was on account of the infimacy of this nobleman with the British ministry, that this favour was granted him. The nature of the conversation with his Lordship, had never transpired on the island. A lady of some rank had lately, in returning from India, endeavored to get introduced to him, and for this purpose a splendid ball was given her by the Governor, to which Napoleon was invited; but he took no notice of the invitation .- Lord Somerset, in returning from his command at the Cape, had also solicited an audience, but Bonaparte refused to see him. It was observed he had never kept hunself so entirely secluded for such a length of time; that he was seldom the subject of conversation, and was hardly thought of by those on the Island; and the latest news they get from him is frequently via England. His appearance is said to be the same as when he landed except his having become more corpulent. His bealth is very good. --- He is abundantly supplied with every thing necessary and convenient. His newmansion was nearly compleated, and was described as being very spacious and elegant. Sir Hudsor. Low still commands on the Island. The naval force consisted of the Vigo 74, the flag ship of Admiral Lambert, who had then commanded on the station about 4 months; the Menai ship of 26 guns, Capt. Shannon ; Redwing, Captain Roberts and Heron. A large merchant ship was there, and was employed in importing supplies for the island and fleet. A brig, tender to the flag ship, was employed between the island and Cape of Good Hope, for supplies, &c. The Heron was to sail for England in a few days. A vessel, supposed from her signals to be a gun brig, was going in as the Juno came out. The story reported some time since of a ship apparently dismasted, having appeared off the island, under suspicious circumstances, had no foundation in truth. A schooner had been signalised often from the heights for upwards of a forenight, and by her superior sailing she eluded the station brigs which were frequently in chase of her. It is most probable she was a Patriot privateer watching for Spanish Indiamen .--- There are about 2000 inhabitants in the island at present. The number of troops is about 2000, who occupy the several stations, all around and over the island. It was healthy at St. Helena. AMERICAN RIGHTS !!! Extract of a letter to the editor of the Emancipator, from a correspondent in Norfolk, (Virginia,) dated August 27th, 1820. " There is now a law in this State, which took place the first day of January last, which prohibits schools being kept for teaching coloured people, under the penalty of three dollars for every offence, if fice, cr 20 lashes on the bare back ; or if slaves, 20 lashes. It subjects white persons to the same penalty --- and enjoins on all magistrates
