" My wife, who had a Sabbath school for coloured children, which she taught gratis for 3 or 4 years past, has been compelled to give it up, although none were admitted but those who were free, and those who had written permits from their owners. She had more than a hundred scholars at a time; although the school was supported by some of the best men in town, and several of the magistrates, yet I was presented before the grand jury, and nothing saved me but the presentment being made before the law became in force. Before I consented for the school to be broke up, I consulted with the State's Attorney, who was much in favour of the school, and a pious man, who said it. was so pointedly against the laws, that he himself, as the prosecutor, would be obliged to take notice of it.

" I am so disgusted with my native State, that if I could dispose of my property without 100 great sacrifice, old as I am, I would remove to a land of liberty !!!"

A serious question occurs --- whether our fificen hundred thousand African slaves are less worthy of moral and religious instruction than the pagans of Hindoostan? The latter, though sunk in the depths of pagan darkness, are comparatively free and happy:---The former, deprived of personal, civil and religious liberty, are generally subjected to severe servitude, and often to hunger, cold and nakedness, ignorance, contempt and scourging, having no comfortable dwellings, and the females constantly exposed to the most brutal ************

A peculiar case of distress. The following distressing case is made known to the Inhabitants of Fredericton, in the hope that they may be led to commisserate and relieve the suffer-

ings of a fellow creature: GABRIEL DHLBACK, a native of Sweden, 16sides on the Miramichi river, a listance of about sixty miles from Fredericton. Before May last, a gathering commenced in his leg, and from the want of proper care, a mortification took place Thus suffering the greatest agony and pain; he was led to saw it off a little below the knee. In this state, he and his wife, with a child of six months old, left their place of residence, and travelled to Fredericton on a sled. A short time after his arrival, when he had gained sufficient strength, he had to undergo the severe operation of having his leg amputated above the knee, as the only likely means of saving his life; and he is doing well. As he is now rendered unable of supporting his large family, of a wife and nine children, and being but in poor circumstances and far from his home, his case is humbly laid before a benevolent public, in the hope of meeting with its compassion.
