EXTRACT FROM THE Letter from the Queen to her People, IN REPLY TO THE ONE FROM THE KING.

" Nothing Extenuate, nor set down aught in Malace."

BRANDENBURCH-House, New Year's Day. To all my Loving Subjects, of whatever denomination, the QUEEN sends her most affectionate Greeting :---

As the King has chosen to address his subjects in the form of a Pamphlet, I am justified in doing so. Situated as I am, I have no otherway of making my sentiments known to my faithful People, than through the medium of the Press. The King has his Parliament to which he can appeal, and, in adopting any other method of communicaing with his subjects, I humbly conceive he not only derogates from his dignity, but acts contrary to the Statue Law of the realm.

I wish I could for ever blot from my memory the day of my very unfortunate marriage, sacrifice I shall call it, as from that hour I have never known peace or happiness. It could not be supposed that love existed betwixt two persons who had never seen each other until a few days before their marriage; but I had heard so much of the amiable qualities of the Prince of Waleshis gentlemanly carriage—humane disposition, and tenderness to the female sex, that I hoped to pass my life in as much comfort as could be expected, where the union was political, and the inclinations were never consulted.

However I have been deeply disappointed, and to this hour no one knows what I have endured. With the causes of our seperation the world are not acquainted, nor can they be by me. Time will remove the veil, and posterity honour me for a silence persisted in from the purest principles of female delicacy.

When I presumed to complain to my family of the treatment I was receiving, my letters, it is well known, were stopped and broken open and the natural appeal of a child to its parent was construed into a want of respect for the husband who had abandoned her in the morning of her youth before she could be charged with the crime of old age.

The silence of my family on this unhappy occasion may readily be accounted for. When the most powerful monarchs of Europe trembled on their thrones, my Father had just reason to dread the loss of his DUKEDOM. Situated in the very centre of the war, he had need of a friend, and in GREAT BRITAIN be found one, whom it was his interest, and the bounden duty he ewed to his subjects, not to offend: he thus sacrificed his private affections at the shrine of public interest, and I became the victim of his magnanimity. The grave has long closed over him, and I feel happy he did not live to witness the sufferings his daughter be since endured.

It is well understood that the PRINCE of WALEs had for his object in marrying, the haymen's of his debts; if such were actally the case, I was from the first only considered as a piece of parchment, or a

can any one doubt then, but that the first wrong was done to me? and that by one of whom, -it is said by the Bishops-is he can do no wrong."

As no crime had even been proved against me, I would have been justified in demanding a restitution of my conjugal rights. This I never thought of, for surely if I am a woman of that " lofty and daring spirit" I am said to be, I would not demean myself by sueing in vain to a man who had married me from policy, and deserted me from caprice when his objects was obtained. Besides, I could have no wish to renew a connection with one who did not esteem my person, and whose inclinations he declared were not in his power. Immediately after the separation in 1796, when I was left a " lone woman" in a land of strangers, without one true adviser, I had to form a humble establishment of my own, and amongst my domestics, spies, in spite of every precaution, insinuated themselves; it was to them of no importance what my conduct was. They had only to calumniate me, and to do so with some feasibility, it was necessary they should be near my person.

I shall say little of the Investigation in 1806, carried back, like the last, for several years; it is only to name the Douglases, to shew that I was innocent, falsely and foully calumniated. If an error in the conduct of the Princess of Wales be a crime against the nation, is it not equally so in the Prince? I have been acquitted of all errors, while others have acknowledged their's, and yet are passed over with impunity. {Remainder in our next.]


