Commissioners for Roads. GRIFFIN CORY ... For the Road leading from the Grand Lake to the Washade-

moak Lake. JOHN SEACORD --- From Long Creek to the Mill Stream.

The Treaty of Ghent We learn, says the Boston Patriot, that there is a disagreement between the English and American Commissioners, under this Treaty, for determining the Eastern Boundary of the United States. It therefore becomes their duty to report their proceedings to their own governments, who, according to the treaty under these circumstances, are to call upon some friendly sovereign, as an umpire. The territory in dispute, contains about five millions of acres, a part of which is good land. It is situated at the north west angle of Nova Scotia, and at the north east angle of the United States, and has within its limits the head waters of the Saint John and other important rivers. There is a French settlement on or near this disputed territory, at a considerable distance from any other settlement, which has been visited only by huniers and surveyors. It is said to be in a very flourishing condition; its situation removing it alike from the temptations and vices of the world."

* The settlement which is here so slightly noticed by the Americans, lies in a N.W. direction from Fredericton, at the distance of about 135 miles. They, no doubt, are well aware of its value to this Province; for notwithstanding its situation, allowing it 10 be visited only by "hunters and surveyors," the inhabitants of this place have received from it in one season, upwards of one thousand bushels of grain and flour; and we understand it has been so well searched after by a hunting party, sent by the Governor of Maine, that a census of the inhabitants in the remote settlement of Madawaska, was taken last season, and is now considered as within the jurisdiction of that State.

We are sorry to say that we had, during the last week, two alarms of Fire, both of which originated in a great measure from negligence. The loriner took place in an unanished building in Brusselsstreet, belonging to Mr. S. D. Sayward, from the carelessness of his apprentices, having left a quantity of shavings too near the fire, during their absence from the house. The injury done was considerable. HALIFAX, Oct. 22.

Piracy.-Capt. Coulson, late of the brig Alligator, of this port, was a passenger in the schooner Hunter, from New-York. He states that he left Jamaica on the 18th August; that on the 24th, he discovered two small schooners at anchor near Cape Antonio, one of which soon after got under weigh, and, by the aid of sweeps, came up with the Allinator in a short time, and sent her libat on board with 14 or 15 men, all Spaniards, armed with blunderbusses, cutlasses, &c. who drove the master down. to the cabin, and the crew forward, ordered the mate to the helm, and obliged him to run the brig towards the shore, where she was anchored near the schooners. The Pirates then commenced plundering the vessel, and made her erew unbend the light sails, which, with all the spare canvas, rigging, and every article of wearing apparel worth taking, they put on board of one of the schooners - after getting the stores, &c. on deck, and searching the cabin and state rooms, they ordered the master on deck, and suspecting there was money on board, demanded to know where it was placed, Captain C refused to satisfy them, and the Pirates then beat him severely with cutlasses, and afterwards suspended him by a rope round his neck down the hathway, and kept him in that dreadful situation until he had nearly expired, and on his reviving a little they again heat him most unmercially with their swords. As soon as the money was removed to the schooner, Capt. C. was directed to get his vessel under weigh and proceed on his voyage, which he immediately ded. The next morning, however, the Alligator struck on the N W side of the Colerados, and in a short time bilged - the crew then took to the longboat and shaped their course for the Havanna, from which place they were distant about 160 miles. On the 25th, they saw a large brig moored inshore, about 20 leagues to the castward of Cape Antonio -she had an avening spread over her deck, and a boat partly hoisted alongside-supposed her a store ship in possession of the Pirates. On Sunday the 26th while pulling alongshore, they passed very near the schooners that had plundered the Alligator, and which fired several shots at them, but they escaped by getting inside of a reef. On the 28th, after being four days in the boar, and suffering great bardships, they fell in with the French brig Narcissa, Capt. Rascar, who received them on board -there they experienced the greatest kindness, and in a few days were landed at the Havanna.

Captain Coulson further informs us, that the boat which brought the Pirates on board of the Alligator, had the word " Greenock" painted on her
