To all whom it may concern Greeting: TOTICE is hereby given that upon the application of James Wood, to me duly made according to the form of the Act of Assembly in such case made and provided, I have directed all the estate as well real as personal within this Province, of Thomas A. Hammond, late of the City of Saint John (which same Thomas A. Ham.
