KINGSTON, May 12.

The transport ship Cambridge, Mason in 43 days from Cowes, having on board detachments of the 33d, 50th and 91st Regis. under the command of Lieut. Graham 334 Regt. anchored at Port Royal, yesterday morning.

May 13. His Majesty's Ship Athol, of 26 guns, Capt. Bourchier, anchored at Port Royal yesterday, from New-York, where she landed Major Gen. Conran on the 19th of April. The Major General was to embark on board the merchant ship Hudson, on the 1st inst. for England. The Athol, in coming into port, saluted the Commodure's flag, which compliment was returned by the flag-ship.

St. JOHNS, N. F. May 23. At a very early hour yesterday morning the inhabitants of this town were alarmed by the cry of " FIRE," which had been discovered issuing from an uninhabited house nearly opposite the Gazette Office. The destructive element soon communicated to the three or four adjoining houses which it ultimately consumed to the ground. By some unfortunate circumstance the engines did not arrive until 20 minutes after the fire had broke out, and when we reached the spot the utmost consternation and indicision prevailed, from the want of means to extinguish the flames.

The Royal Artillery and the officers and men of the 74th Regt. acted nobly, and with the co-operation and vigilent exertions of the respectable Inhabitants, prevented the ravages from extending beyond the batch of houses among which it had originated.

May 30. By the arrival of the schr. Cod-fish, from Burin, we have learned the following distressing particulars of the loss of the schr. Mountstone, James Coleman, Master, of and from Plymouth, bound to this pert. The Mountstone sailed from Plymouth on the 6th April, on the 6th May, lat. 46 10 lon. 45, 30, fell in with the ice, when the vessel immediately hauled to the wind, in coming to she struck a pan of ice, which broke her rudder; she then became unmanageable, drifted into the ice and bilged. The crew and passengers, ten in number, had only time to get out the boat, and quit the vessel without any provisions or water; they then got on a pan of ice, and remained thereon that day and the following night, when they were obliged to launch the boat and quit it, in consequence of the heavy sea which broke over them. Lieut. Rothwell, a passenger, died on the 11th; two men died on the 12th, at the time of making the land; and on the 14th they were picked up by the beig Matty, Coffee, from Liverpool, bound to Burin; at that time only three persons remained alive in the boat-the Master, who is exceedingly ill. but likely to recover; the owner, Mr. Hodge, who died since and was buried in Burin; and one other man whose life is despaired of. A son of Mr. Hodge, a youth of about 18, was a corpse in the boat when picked up. Journal.

Letters from Mont Louis, frontiers of

Catalonia, dated April 26.

"The division of Gen. Padien, which was to have invested Figueras, has been commissioned to a service of greater imporrance -- That of covering the valley of l'Arriege, and clearing the mountains of the army of Mina. This General now occupies the plain of Vich with 12,000 men. Seo d'Urgel is desended by 600 men; Campredon, Olot, and Berga, are garrisoned; so that the Segre and the Ter are occupied by the enemy, who flank the position of the Marshal now before Figueras, and who menace his advance. The whole warfare is confined to the mountains, and it remains for the noth division to have the honor of terminating it. It is, therefore, to General Donnadien, that this duty is confided

whose division we are earnestly endeavouring to complete. 2,800 men, besides Querillas of Romagossa and Mirales, from 1,000 to 1,200 men, to whom this important mission has been confied, are now at Puycerda.
