

Dr Henry Miller, lately travelling from Sunkhays, U.S. up the Penobscot river, happening to fall in company with two gentlemen who were bound for the river St John, related an account of a most marvellous phenomena, of which himself was an eye witness. There was a certain monstrous Spirit, whose supposed residence is on the Cathardin mountain. which lies westwardly on the river Penobscot, had made his appearance on a branch of the Mattawampkeig Creek, called the Moluncas : it had also been seen on Eel River, which empties itself into

The account given by the Doctor of this dreadful Spirit, almost exceeds description, and indeed appears calculated to strike terror into a person of the most magnanimous disposition.
