MELANCHOLY ACCIDENT.

Yesterday morning Mr. JOHN CARD, a native of the United States, whilst working in Mr. Dow's ship yard at the Oromocto, was instantaneously killed by the falling of a plank from the upper staging of a vessel which was building in that yard; we understand that he has left a wife and four children to lament the loss of an affectionate companion and kind parent. His remains will be interred to-morrow at 12 o'clock, with Masonic honors.
