THEREAS in and by the Act of Parliament passed in the third year of His Majesty's Reign, intituled "An " Act to regulate the Trade between His Majesty's Possessions in America and the West Indies, and other Places in America and the West Indies," there is no permission granted for the Importation into this Province, of Dead Meats of any kind: All Persons concerned are therefore hereby notified, that the Importation of Dead Meats of all kinds, from the United States of America, into this Province, is prohibited: And any such Articles imported or brought into this Province from the said United States, after the date hereof, will be proceeded against as Articles illegally Imported.

NEW-YORK, DEC. 17.

A Bill to repeal the 3d section of the Act of May 15, 1820, which prohibited importations from the British Provinces in North America and the West-Indies, except of articles the growth or manufacture of the place where the same was laden, also passed the House on Friday, and was sent to the Senate for concurrence .-- For the information of our mercantile readers we publish that section of the act.

Sec. 3. And be it further enacted, that from and after the 13th day of September next, no goods, wares or merchandize, shall be imported into the United States of America, from the province of Nova Scotta, the

Province of New-Brunswick, the Islands, of Cape Breton, St. Johns, Newfoundland, or their respective dependencies, from the Bermuda Islands, the Bahama Islands, the Islands, called Caicus, or either or any of the aforesaid possessions, Islands, or places, or any other province, possession, plantation, Islands, or place, under the dominion of Great Britain in the West Indies, or on the continent of America, south of the United States, except only such goods, wares, and merchandize, as are truly and wholly of the produce or manufacture, of the province, colony, plantation, Island, possession or place aforesaid, where the same shall be laden, and from whence, such goods, wares or merchandize, shall be directly imported into the United States, and all goods, wares and merchandize, imported or attempted to be imported into the U. States of America, contrary to the provisions of this act, together with the vessel on board of which the same shall be laden, her tackle, apparel and furniture, shall be forseited to the United States.

SUPPRESSION OF PIRACY.

It will be seen by the Congressional Diary, that a bill to appropriate 160,000 dollars for the purchase or construction, of armed steam boats, schooners, and cutters, for the entire destruction of the buccaneers of the West-Indian seas, passed all its stages in the* House of Representatives, the 13th inst.; and that a bill for the same object had two readings in the Senate, in one day, and was ordered to be engrossed by unanimous con-This is despatching public business. It will also be found, by advice from the Dahamas that the expedition from thence had and captured several of them; and that hopes were entertained that the nest had been whol-. ly broken up. This, if true, will give leisure to the Executive to build the new contemplated vessels, and thus add to the naval force a species of vessels much wanted for various purposes; as it is probable our cruizers and those of the British, on the Cuba station, will be able to prevent the formation of any new nests of marauders. The Spaniards, it also appears, are now in earnest, in their cooperation for the destruction of the pirates, and report adds, that they have promptly executed 22 of them, which escaped to the Island .-- Boston Cent.
