BATAVIA, June 8. Private information from Manilla of the 5th of April last, states that a few days before a conspiracy among the troops had en discovered, the object of which was to depose the Governor and to proclaim Indebendence. The Governor had taken proper precautions in time, and had caused the mutinous to be in part disarmed and in part ent to Cavila, three leagues from Manilla-Great agitation still prevailed in the city.

The same account says, that the cholera morbus had entirely ceased at Manilla.

NUREMBURG, Oct. 24. We have received from Warsaw also the oritive information, that the greater part of the Russian. Western army, which was to have fallen back into the interior of the Empire, had received orders to retain its present rosition. It is also observed that the new winter quarters of the Southern army are very much concentrated, and the troops are distributed in such a manner that they may be united at a very short notice, if the Turkish army on the right bank of the Danube should make any movement indicative of hostile intentions.

Paris, Oct. 31. It was yesterday announced that it has been resolved, as a basis, at Vienna, that the King of Spain shall be re established in all his rights. The means, it is said, will be liscussed at Verona. At the first conference between the Ministers of the four great powers of the Holy Alliance, the Duke of Wellington alone, of all the foreign Plenipotentiaries, was allowed to be present.

SMYRNA, Aug. 2. We continue to receive particulars of the late events in Athens. The following are in adition to those given in cur last.

When it was found that the Turks in the citadel were famishing for want of water, and that a capitulation was inevitable, the French and Austrian Consuls (M. M. Fauvel and Gorins) requested for the benefit of both parties, that they might witness the signing of it. From the excitement of the Greeks (who had heard of events in Scio) they feared what has since happened, and they each sent circulars to the French and Austrian naval. commanders, requesting their presence in the neighbourhood of Athens, to enable them to afford protection to such of the Turks as should take refuge under the flags of their respective Sovereigns. They could not interfere to save the 700 or 800 who were first made the victims of the fury of the Greeks; but they were determined at all hazards to execute their treaty right; to protect those who sought an asylum in the Consulates. The officers of the French squadion were prompt in obeying the requisition, and immortal credit is due 10 Commodore de la Meillerie to the Chevalier de VIella, to M. de Reverseau, and to the Lt. Commandant d' Argous, for that promptitude.

[Here follow numerous particulars of the exercions of the above named officers and their men in effecting the escape of the Turks, which we have not room for. One of them was imposing an embargo on, all the vessels in the Piræus, by which between 2 and 3000 Greeks who had fled to this port of Athens were prevented from embarking until the Greek captain of the port had given his word of honour to the French officers that the Turks should be allowed to embark in safety. This had the desired effect. It appears that this handful of Frenchmen ran great risques, and the Greeks threatened frequently to burn them alive. But by great courage and address they succeeded without loss, in saving nearly 400 human beings from assassination. The account concludes thus]---

The conduct of Messrs. Argous and Reverseau proves that the unfortunate who take refuge under the flag of his Majesty Louis the 18th do not do so in vain. Had the Greeks been in the same crinical circumstance that the Turks were in Athens, they would have received the same protection that

was given to Mussulmans."

ATHENS, Aug. 24. The Acropolis continue in possession of 300 or 400 Greeks. The Turks do not appear anxious to storm the citadel which must fall an easy conquest when the Peninsula (Morea) has submitted to their power.

HEREAS it appears that the number of Taverns heretofore licenced within the County of York, is far greater than is necessary for public convenience, and many persons have obtained Tavern licences for the sole purpose of selling spirituous liquors, without having the means of furnishing the requisite accommodation for Travellers, which is found a great publie iujusy and destructive of the morals of the people. Resolved therefore that the following Regulations be adopted with regard to the granting of licences for Taverns in future, within the County :

1st. That in future no licence for keeping a Tavern within the Town of Fredericton, be granted to any person unless such person shall be able to prove to the satisfaction of the Court, that he can furnish at least two good beds, four suitable stands for horses, two separate rooms, and such other accommodation for Travellers and others who may require it, as shall appear to the Court to be

necessary. 2d. That no licence be granted for keeping a Tavern in any other part of the County, unless the applicant shall be able in like manner to prove to the satisfaction of the Court, his ability to furnish at least two beds,

and six stands for horses, one private room, and such other accommodation for Travellers as the Court shall judge expedient.

3d. That no licence in future be granted for a less sum than two pounds.

4th. That in future every application for a Licence be in writing, containing the name of the applicant, his place of residence, and state particularly the number of beds that he can furnish, and the other accommodations in his house and stables, and that such application and statement be accompatited by a Certificate of a Magistrate resident in the Parish, which Certificate shall prove the truth of the statement made by the applicant, and shall also express the opinion of the Magistrate respecting the expediency of licencing such Tavern.

5th. Ordered that the preceding Regulations be forthwith published in the Royal Gazette, and also in hand bills, to be distributed throughout the County, in order that all persons concerned may be duly apprized thereof, and govern themselves accordingly.
