Army of the United States.—By the official report of the organization of the army, according to the act of Congress of 2d March, 1821, it appears that the whole number of non commissioned officers, musicians and privates, is 5642—commissioned officers, 541, including one Major and two Brigadier Generals, one Adjutant and one Quarter Master, and two Inspector Generals, two Quarter Masters, one Commissary General of Subsistence, one Paymaster General, 14 Paymasters, one Commissary General of Purchases, two Military Storekeepers, one Surgeon General, 8 Surgeons, 45 Assistant Surgeons, 10 Top. Engineers and Assistants, 12 Colonels, 12 Lt. Colonels, 13 Majors, 116 Captains, 296 First and Second Lieutenants.

JANUARY 1.

Another Canal has been projected in N. York, from Sharon, Conn. to the Hudson. One project proposes to carry it to New-York, a distance of one hundred miles, and another to Sing Sing, sixty-five miles. The fall is computed at 450 feet, requiring 45 locks.

JANUARY 3.

Courier Office, Charleston, Dec. 23.  
"The schooner Comet arrived this morning in 5 days from Havana, bringing dates to the 17th inst. Our correspondent writes us that the city of Havana was in a perfect state of Revolution. The natives (Creoles) have declared themselves enemies to the Europeans, and it was expected the matter would soon come to a serious end. The leaders of the first, are all the learned young men of the city, and of the second, all the Grocers and Catalonians. Produce had fallen considerably in consequence of this affair."

DEFEAT OF MORALES.

We yesterday stated sufficient reasons for doubting the accuracy of the reported and much-boasted victory of Morales. We now find by the following, which we copy from the Exchange Commercial and News Room that the triumph, as might have been ex-

pected, rests with the republican troops of Colombia.

Captain Maion, of the schooner Cherub, who arrived at this port yesterday from Curacao, states that the day previous to sailing, a schooner arrived in two days from Coro, by which letters were received from Governor Torrelles, at that place, giving information of two battles having been fought on the 2d and 24th of November, at and near Salina Rica, between Generals Montilla and Morales, in both of which Colombian forces proved victorious. The royal troops in consequence were obliged to evacuate Maracaibo on the 26th, and that place was taken possession of the same day by General Montilla. The Spaniards, it is stated, suffered severely in the last action, having lost the entire battalion of Varinas, and many officers. On the 27th, Morales, with the remnant of the army, in all about 600 men, landed at Alta Gracia, and reached Mitara on the 29th. General Torrelles was making every preparation to receive the beaten forces of the Spaniards, and no doubt would be able to keep them in check until assistance could be procured from Burquismeto."

Confirmation of the above.

We have just been assured by a gentleman arrived here, that he read the official dispatch from the Governor Torrelles to Gen. Soublotte, Intendant of Venezuela, detailing and confirming the above victories by the Patriots over the Royalist General, Morales. Fed. Gazette.

FROM VERA CRUZ.

By the arrival at New-York of the sch'r Fly, Capt. Boyer, in 20 days from Vera Cruz, the Editors of the Mercantile Advertiser have received Mexican papers to the 30th ult. inclusive.

The U. S. corvette, John Adams, Capt. Renshaw, sailed from Vera Cruz, Novr. 28th, from Tampico, to take on board Mr. Painsett. She had on board 40,000 dols. for New-York, and expected to take on board at Tampico, 300,000 more, from whence she would proceed to this port by way of Havana. Four Spanish ships were to sail in a few days for Havana, with 3,000,000 of dollars on board, as was supposed.

It was impossible to know what was going on politically, as every thing was conducted with much mystery and secrecy. At one day it was said there was a public declaration of war against Spain, and that all communication was to be immediately stopped—but there was nothing to warrant these reports. The communication with the castle was open, and Spanish ships continued to arrive.

THE PIRATES AT PENSACOLA.

Extract of a letter from a Gentleman in Pensacola, to his friend in this City.

"My last informed you that the crew of the Carmen, captured on the Coast of Cuba, by the sloop of war Peacock and cutter Louisiana, had been brought in here and committed by Judge Breckenridge for trial. The Spanish inhabitants immediately afterwards, raised a subscription for them, and employed counsel, though it is understood they have since received ample credits from New Orleans, and the Judge has admitted the chief of them to bail. It seems they had no commission to cruise, but had a complete warlike outfit more than twice the number of men upon their roll, and carried the bloody flag worn by the pirates on those seas. I lament to learn that the Peacock has lost during the cruise, so many of her officers by the fever. Larna, the mayor, and others of the principal Spanish inhabitants are the bail." Richmond Enquirer.

The New York Mercantile Advertiser of Monday last, says—"The arrivals at this

port last week, were very few, although many vessels were expected. It is stated to us, as a remarkable circumstance, that during the whole of the week, not a single bag of sugar or coffee, nor a hoghead of molasses, was imported from any foreign port.

NEW-YORK, Dec. 31.

Importation of Wheat.—The Meteor, which arrived yesterday from Liverpool, has on board 2000 bushels of Baltic Wheat, and we understand the Magnet, which sailed in company for this port, has on board 4000 bushels. At the present price in this market, the article will pay a good profit, perhaps better than any other heavy article that could be brought.

A paragraph in an Havana paper intimates the probability of the new Emperor of Mexico being about to fly to the United States with several millions of dollars. Although this is an event (says the Charleston Courier) which may very possibly happen at no remote period, perhaps the time has not yet arrived which would render such a step necessary for the preservation of his head.

At last dates from Havana, the new Captain General (Vives) had not reached that place; but a vessel of war had left Cadiz, and proceeded to Corunna, to receive him on board, and was daily expected at Havana.

The Commissions appointed some time since by the Cortes of Spain, for the pacification of Mexico, have arrived at Havana.

JANUARY 8.

Expedition against the Pirates.—The nine schooners purchased in Baltimore by Captain Porter, arrived at Norfolk on the 25th ult. These, together with the steam boat and merchant ship purchased at New York, and which have probably ere this arrived at Norfolk, will form a respectable and efficient force to operate against the pirates. In addition to the ordinary complement of seamen, &c. the squadron will carry out 100 marines. If the success of the Commodore's operations, (remarks the Baltimore Gazette) should correspond with the celerity of his movements, danger from pirates, will not long continue, as it is now, the most prominent in the calculation of risks at our Insurance Offices.

We have received by the brig Ladies Delight, a Curacao paper of Nov. 30th. The Spanish frigate Ligers, at that place, brought a number of emigrants of both sexes from Porto Cavallo. It is said a new Captain General has arrived at Porto Rico, to supersede General La Torres.

A letter from Laguna mentions that Mr. Zea, has raised upwards of nine millions of dollars in London, for the Columbian government, and bought an immense quantity of clothing and necessaries for the army.—N. Y. M. Adv.

FROM RIO JANEIRO.

We learn from Captain Rudder, of the Brigantine Decatur, arrived here from Rio Janeiro, which place he left on the 5th Nov. that the affairs of that Country were in a very unsettled state, at the time of his sailing. The badge of "Independence or Death," which denoted the adherents to the new Emperor, was not recognized with cordiality by many of the inhabitants. New laws and edicts were daily promulgated, and many of those attached to the ancient order of things, were preparing to leave the country. These, anxious to get rid of the paper currency in their possession, had gone into the market and purchased all the coffee they could lay their hands on, which had caused that article to advance from 54 to 5700 rs. the arroba.

The Prime Minister has resigned his office, and nearly all the other members of the cabinet had followed his example; but this
