Extract from the Minutes of the House of Assembly, July 16th, 1823.] The Speaker stated that he had a communication addressed to him by his Excellency the Governor, which he read, and is as follows :--

Government-House, Tobago, July 16. SIR. disturbance. ing my application to the House.

I feel it my duty to address you for the information of the House of Gen. Assembly, in consequence of the extremely critical state of the Colony, with respect to a place of refuge and defence, in the event of any internal The fort in its present state is not to be defended by a small garrison now occupying it nor even with the assistance of the whole white population of the Island. I have done all that my slender means allowed me to do, and still the fort is untenable. I have applied elsewhere for pecuniary assistance, which, if granted, may come too late for our benefit. The Ordnance Department has undertaken to perform a very expensive and laborious part of the work, but it is not yet begun, nor can I vensure to say when it may be commenced, and in the mean time the most serious consequences may ensue. ## ST. CHRISTOPHER, JULY 15-

A special meeting of the Legislature took place on Saturday last; when discussions were had on some recent communications from His Majesty's Government, in reference to the Slave population, and arising out of the late proceedings in Parliament on the subject .- A report of the joint Committee of the Council and Assembly, appointed to consider of and to devise such measures as at this crisis appear necessary, was brought under the consideration of the two Houses, and the measures suggested, will further engage their deliberations at the next meeting, which, in regular course, will take place on Friday.

The following Resolutions passed the House of Assembly :-
