MATHEREAS the General Assembly of this Province stands prorogued to Wednesday the fourth day of June next ensuing, I have thought fit, by and with the advice of His Majesty's Council, further to prorogue the said General Assembly, and the same is hereby prorogued to Wednesday the twenty-fifth day of the same month of June, then to meet at Fredericton for the dispatch of business.

HEREAS in and by two certain

Acts of the General of this Province, made and passed on the twenty-seventh day of March in the fourth year of His Majesty's Reign, one of which Acts is intituled "An Act to repeal an Act to increase the Revenue of this Province by imposing a duty on certain " Merchandize," and the other of which Acts is intituled "An Act to alter and " amend an Act intituled an Act to pro " vide for the support of a Light House to " be built on Partridge Island." Such provisions and enactments are made, that from and after the passing of the said Act, no duties of tonnage or impost, and no charges of any kind, are levied or exacted upon the Vessels of the United States of America admitted into the Ports of St. John and Saint Andrews in this Province, being two of the Ports enumerated in the Schedule marked A, annexed to a statute of the United Kingdom of Great Britain and Ireland, made and passed in the third year of His Majesty's Reign intituled " An Act to re-" gulate the Trade between His Majesty's Possessions in America and the West Indies and other places in America and the West Indies," or upon any Goods Wares or Merchandize imported therein, in the said Vessels other or higher than are levied and enacted upon British Vessels, or upon the like Goods, Wares, and Merchandize, imported into the said Ports from elsewhere.

make known the same.

I have therefore thought fit to issue this Proclamation, hereby declaring that no other or higher duties, and no other charges of any kind are levied or exacted upon the Vessels of the said United States admitted into the said Ports, or upon any Goods, Wares or Merchandize, imported therein in the said Vessels other than upon British Vessels, or upon the like Goods, Wares, or Merchandize, imported into the said Ports from elsewhere.

Whereof all persons whom it may concern are to take notice and govern themselves accordingly.

A Proclamation. THEREAS several Persons have memorialed for Licences to cut Pine Timber off the Crown Lands, without coming forward to take out the same, and have their Births surveyed agreeably to regulation --- Such Persons are hereby cautioned against proceeding to cut the Timber applied for, under the penalty of being proceeded against in common with other Trespassers.

A list will be published in the Royal Gazette, of the names of those Persons who have taken out their Licences and complied with all the requisite conditions; after which notification, no more Licences will be granted for the present Season.

THEREAS in and by His Majesty's Royal Commission and Instructions to the Governor of this Province, it is provided that " in the event of " the death of the Lieutenant Governor, the " Senior Member of the Council who shall " then be residing within the Province " shall take upon him the Administration " of the Government, and execute the said " Royal Commission and Instructions, and " the several powers and authorities therein " contained, in the same manner and to all intents and purposes, as other His Ma-" jesty's Governors or Commanders in " Chief should or ought to do in the ab-" sence of the said Governor, until his re-" turn, or in all cases until His Irlajesty's " further pleasure be known therein." And whereas in and by the said Commission and Instructions it is further declared to be His Majesty's Will and Pleasure that the Governor of the said Province do, upon his appointment, " fit himself with all con- without any legal authority, and are null and venient speed to repair to the Seat of void, and of no effect. And whereas upon the death of the late Lieutenant-Governor and Commander in Chief of this Province, His Majesty's Council having forthwith assembled, and taken into consideration the said Commission and Instructions, did thereupon order that notice be immediately sent by express to the Honorable GEORGE LEONARD. the Senior Member of the Council, apprizing him of accordingly. this Event, and requesting him to repair immediately to the Seat of Government and assume the Administration of the Government, and in case he should in any way be prevented from repairing immediately to the Seat of Government, that he should be requested to signify the same in writing, and that thereupon the like notice and request should be sent forthwith to the Honorable CHRISTOPHER BILLOPP, Esquire, the next Senior Member.

And whereas neither the said GEORGE LEONARD, nor the said CHRISTOPHER BILLOPP, did, as required by the said Commission and Instructions, repair to Frederiction. And it appearing to His Majesty's Council to be necessary, in conformity with the said Royal Commission and Instructions, that the Person to administer the Government should be sworn in at Frederiction, being the Seat of Government of the Province; and the exigencies of the Province admitting of no delay, It was thereupon resolved, that the next Member in succession on the list of Counsellors should be admitted to the Administration of the Go-

And whereas, being next in succession upon the list of Councillors, and being present in Council, I did thereupon, by and with the advice and consent of the said Council, on the first day of April last, take the usual and requisite Oaths, and did assume the Administration of the Government, as President and Commander in Chief of the said Province, until His Majesty's further pleasure be known therein; and no other Person has been appointed and sworn to Administer the said Government.

And whereas the Person to Administer the Government is, by sundry Acts of Parliament relating to Trade, to take the Oaths therein mentioned, before his entrance into his Government.

And whereas the said CHRISTOPHER BILLOPP, not regarding the said Commission and Instructions, and the said several Acts of Parliament, did cause to be printed and published in the City of Saint John, certain Instruments, purporting to be Proclamations in his name, as Administrator of the Government and Commander in Chief of the Province, in which Instruments it is declared that all Proclamations, Civil Appointments and Public Acis whatsoever done and issuing in my name and by my authority as President and Administrator of the Government of the Province are absoluvely illegal and of no effect, to the disturbance of the Public Peace and great disquiet of all His Majesty's Faithful and Loyal Subjects in this Province.

I have therefore thought fit, by and with the advice and consent of His Majesty's Council, to issue this Proclamation, hereby to make known and declare that the said Publications so printed and published as aforesaid, by and in the name of the said CHRISTOPHER BILLOPP, are altogether

of this Province, unless the same shall be previously authenticated by Publication in the Royal Gazette, printed at Fredericton, and by the official signature thereto of the Secretary of the Province, or his Deputy thereunto lawfully authorized, or by some or one of those marks of authenticity. And I do hereby require all Magistrates and public officers and all other His Majesty's faithful and loyal subjects, to take due notice of this Proclamation, and to govern themselves
