

o this vast and gigantic resolution, the Emperor Alexander has recalled all his accredited agents from the Brazils, and an expedition is forthwith to be forwarded from Spain, under the flag of that nation, against the Republic of Columbia. This expedition of consist of twelve thousand soldiers, nominally Spaniards, but fitted out at the expence of France, attended by French artillery and engineer officers, and the necessary number of priests and licensed spies, who may by bribery, fraud, and fanaticism prepare the way for tyranny. — *Mon. Chron. Oct. 30.*

The accounts from Paris of the 28th, speak of an agitation in the stock market, in consequence of rumours of naval preparations in England, &c.

The Theis frigate sailed from Plymouth, Oct. 19, for Mexico, with Mr. Lionel Harvey, and Mr. Ward, Commissioners, and three Consuls. The Isis sailed on the 20th, with Col. Hamilton, and Col. Patrick Campbell, Commissioners, and five Consuls for Colombia.

It is stated that the Commissioners are to enter into commercial treaties, and establish a political understanding conformably to the instructions they carry out. If they succeed, and the South American Governments consent to the residence of Consuls in their ports, the functions of the latter will then commence and every six months they are instructed to send home a Report of the imports, exports, productions, &c. of their several departments.

We learn from good authority, that it is a settled point that France is to continue the military occupation of Spain to a certain extent, and for a definite object, namely, until the Government of Ferdinand is entirely and firmly re-established. In pursuance of this plan, Cadiz will be occupied by 10,000 troops; Madrid by 5,000, and 15,000 will take up positions along the line of the Ebro. One great point which it is intended to accomplish, if possible, is the entire disbanding of the Spanish army, as now constituted, and to remodel it upon a totally different system. It is hoped that this will materially accelerate the restoration of internal tranquillity. — *Courier.*

Mina, and Rotten, have replied to the summons of the King, that they require a precise order in the hand writing of Ferdinand, to be brought by a Spaniard.

Many Constitutionalists are still in arms in various parts of Spain. Barcelona Carthagena, and Alicante had not surrendered. Sego Urgel had submitted, and Lerida was negotiating. — The French Marshal Oudinot continues disgusted with what occurs at Madrid. The French however, do not interpose much to controul the excesses of the Spanish Royalists.

Anarchy prevails in several towns in Spain, from the persecution of the Liberals by the Royalists.

Riego had been sentenced to death, for voting for the deposition of the King at Seville, and for a Regency. It is said that he will be sent to France.

Accounts from Cadiz are to Oct. 10th. The Constitutionalists continue to emigrate, some merchants among them. A frigate carried the regents and deputies to Gibraltar.

The birth day of the King of Spain was celebrated at Seville, on the 14th. The British Minister was present, and congratulated him on his happy liberation.

The Duke de Montemar is appointed President of the Councils of the Indies.

The Inquisition, it seems, is re-established, and the General of the Capuchins appointed Grand Inquisitor.

King Ferdinand has issued decrees, from Seville, denouncing pernicious books, and directs a commission to inquire what looks are fit for Spaniards to read.

An advance took place in Spanish bonds in London on the 30th Oct in consequence of a report received on that day, that the King of Spain had modified his decree with regard to the loan. Bonds of 1821 rose from 26 to 30, and the New Stock from 20 to 23½.

The King of Portugal has directed a contract to be made for a new loan of ten millions of dollars, and has ordered measures to be taken to improve his revenue. Another conspiracy is said to have been discovered at Oporto.

A meeting took place between the Emperors of Austria and Russia regarding the future state of the Turkish Empire on the

6th of Oct. which lasted only for an hour and the final arrange of the object of this meeting was left to their Prime Ministers.

In perusing your last week's paper, I observed the death of Mr. EDWARD M'CREA recorded. Having been acquainted with him in his native country, permit me to pay a passing tribute to his memory.

He was born in Springtown, in the County Fermanagh, in Ireland, and was employed for many years as a cloth and yarn merchant, from which business he derived the most laudable character. He came to this country in the year 1818, where he remained till his death, beloved by all to whom he was known. Both in his native country, and in this, he will be long and much lamented. We may in justice say, he was a peace maker—a father to his countrymen—and the stranger's friend. His character was highly exemplary, his heart expanded with philanthropy, and his hand was ready opened to relieve the indigent. In the prime of life, in the midst of prosperity, he was suddenly taken away. May we submissively acquiesce in the will of God, and hear the warning voice, “Be ye also ready, for at an hour when ye think not, the Son of Man cometh.”

By his will he directed that his body should be enclosed in lead, bound with hoops of the same, and instead of being com-

mitted to the earth, to be taken to the sea, three miles S. S. W. from Sail Rock (W. Quoddy Head) and there at sunrise, committed to the deep, with his face towards the Sun, “in reverence to the second God of Nature whom he worshipped,” and to ensure the compliance with these directions, gave very considerable legacies to two persons, on condition that they carry them to their full effect; and this morning they were complied with. He also directed that the mourning dress should be dove silk, with the Sun painted on the left arm, and the plate on his coffin to bear also the emblem of the Sun, which directions have been followed. — He had for about three years been unable to walk, owing to a paralytick affection, but retained his senses fully till within a few hours of his death, when he became both speech and senseless.
