LONDON, JULY 11.

The Admiralty have directed that no Pursuer of the Navy is to be entitled to half pay until he has passed his accounts and is clear of debt: and that he shall not claim for half pay during the period which he might be in

debt. Pursers must also, by letters to the Navy Board, request to be placed upon the half-pay list, when they are paid off.

A bill has been introduced into Parliament, and read a second time, entitled "an Act for allowing persons charged with capital crimes to make their defence by Counsel." This is an important privilege, and was called for, we think as much on the score of humanity as of fairness.

The Duke of Athol, on behalf of himself and the Lord-Bishop and Clergy of the Isle of Man, has offered to commute the entire Tithes of the island, £6000 annually.

JULY 22.

There are no expresses to-day from France, they are more anxiously expected in consequence of a report that the Spanish Cortes have made overtures to the Regency at Madrid to give up the person of the King.

JULY 23.

It is repeated that the Duke de Angouleme has promised the Regency a French fleet and army to help Spain to reconquer Mexico.

PROROGATION OF PARLIAMENT.

Parliament was on Saturday Prorogued by Commission, his Majesty not deeming it advisable to risk the possible consequences to his health, of going through the fatigue of the ceremony.

The Commissioners were the Lord Chancellor, the Archbishop of Canterbury, Lord Harrowby, Earl of Liverpool, and Earl of Westmoreland.

The House of Commons were summoned to the Bar at two o'clock precisely. The Commission for giving the Royal Assent to certain Bills, and for Proroguing the Parliament was then read, and the several Bills having received the Royal Assent, the Lord Chancellor proceeded to deliver the following Speech:

"My Lords and Gentlemen,

"We are commanded by his Majesty, in releasing you from your attendance in Parliament, to express to you his Majesty's acknowledgments for the zeal and assiduity wherewith you have applied yourselves to the several objects which his Majesty recommended to your attention at the opening of the Session.

"His Majesty entertains a confident expectation that the provisions of internal regulation, which you have adopted with respect to Ireland, will, when carried into effect, tend to remove some of the evils which have so long afflicted that part of the United Kingdom.

"We are commanded to assure you, that you may depend upon the firm, but temperate exercise of those powers which you have entrusted to his Majesty, for the suppression of violence and outrage in that country, and for the protection of the lives and properties of his Majesty's loyal subjects.

"It is with the greatest satisfaction that his Majesty is enabled to contemplate the flourishing condition of all branches of our commerce and manufactures, and the greatest abatement of those difficulties which the Agricultural interest has so long and so severely suffered.

"Gentlemen of the House of Commons,

"We have it in command from His Majesty to thank you for the supplies which you have granted for the service of the year, and to assure you that he has received the sincerest pleasure from the relief which you have been enabled to afford his people, by a large reduction of taxes.

"My Lords and Gentlemen,

"His Majesty has commanded me to inform you that he continues to receive from all Foreign Powers, the strongest assurances of their friendly disposition towards this country.

"Deeply as his Majesty still regrets the failure of his earnest endeavours to prevent the interruption of the peace of Europe, it

affords him the greatest consolation that the principles upon which he has acted, and the policy which he has determined to pursue, have been marked with your warm and cordial concurrence, as consonant with the interests, and satisfactory to the feelings of the people."

Parliament was then prorogued to Tuesday, the 30th Sept.

From Havana, Aug. 19

There has been a most diabolical conspiracy discovered, the ringleaders of which were taken yesterday. The intention was, to upset the present Government. To accomplish which, the negroes and mulattoes were to act their part---and horrid to relate, the negroes were to commence on Saturday night last, in a general massacre of their masters: and said negroes were to be known by having a black ribband in the bosom of their shirts. One of the conspirators became alarmed, about two hours before the fatal blow was to be struck, and requested to see the Governor, who was in bed. After being examined, and no arms found about his person, he was admitted into the governor's room, where he disclosed the intended affair, stating that the governor had but one hour to save the city from being crimsoned with the blood of its citizens. The military were immediately ordered out, and divided throughout the city---the conspirators became alarmed, and nothing was done. Yesterday a man by the name of Lamos, who was to be made governor, was taken up and put in the Moro, as also a priest, who was to be bishop, and two others, the one to be lieutenant, the other, general of Marines. These people are considered the ringleaders, and will no doubt, be put to death. This conspiracy consisted in natives of the island; no European was entrusted with the design.

Martial law is in full force; however, at present, tranquillity prevails. Two hundred persons have been arrested, and are now in confinement.

FROM THE LONDON GAZETTE.

SATURDAY, JULY 26.

This Gazette contains an Order in Council setting forth, that in consequence of British vessels entering the ports of the United States from the ports of His Majesty's possessions in America or the West Indies, with articles, the produce of said possessions, being charged with duty of one dollar per ton, for tonnage duty and light money, and a discriminating duty of 10 pr. ct. to which vessels of the United States, with similar cargoes, from parts in the said dominions are not subject; His Majesty has been pleased to order, that there shall be charged on all vessels of the United States which shall enter any of the ports of his Majesty's possessions in America, or the W. Indies, with productions of the said States, a duty of 40 3d per ton, and further, an addition of 10 per cent. upon the duties in table C. annexed to an Act to regulate the trade between his Majesty's possessions in America and the West Indies, and other places in the West Indies, and America, passed last year.

From the Weekly Chronicle.

The trade of this place is often spoken of by uninformed persons as inconsiderable---trifling, scarcely worthy of notice; and such opinions, travelling as they frequently do verbally, or in the course of correspondence with individuals in Great Britain, and other parts of the world, produce impressions highly injurious, not only to the respectability, but to the Commercial and Agricultural interest both of the town and Province---Nor is it in the power of language alone, however, flowery or eloquent, to correct errors thus widely disseminated, and prevent the mischief which may be expected to flow from them; It is requisite to adduce facts; ere we can destroy reports and assertions thus erroneous: and to such, having been
