And whereas neither the said GEORGE

LEONARD, nor the said CHRISTOPHER. BILLOPP, did, as required by the said Commission and Instructions, repair to Fredericton. And it appearing to His Majesty's Council to be necessary, in conformity with the said Royal Commission and Instructions, that the Person to administer the Government should be sworn in at Fredericton, being the Seat of Government of the Province; and the exigencies of the Province admitting of no delay, It was thereupon resolved, that the next Member in succession on the list of Counsellors should be admitted to the Administration of the Goverument. And whereas, being next in succession upon the list of Councillors, and being present in Council, I did thereupon, by and with the advice and consent of the said Council, on the first day of April last, take the usual and requisite Oaths, and did assume the Administration of the Government, as President and Commander in Chief of the said Province, until His Majesty's further pleasure be known therein ; and no other Person has been appointed and sworn to Administer the said Government. And whereas the Person to Administer he Government is, by sundry Acts of Parliament relating to Trade, to take the Oaths therein mentioned, before his entrance into his Government. And whereas the said CHRISTOPHER BILLOPP, not regarding the said Commission and Instructions, and the said several Acts of Parliament, did cause to be printed
