ST. ANDREWS, JUNE 10.

We regret to state that several cases of the Small Pox have appeared here; those persons known to be infected, have very properly been removed to Chamcook and Hardwood Islands, and, we are happy to learn are doing well. The disorder exists likewise at Deer Island, and, as we are informed, at Eastport. Under these circumstances we connot too strongly recommend speedy vaccination as the most effectual antidote to this pestilent scourge of the human race.

Saint John, June 19.

We are happy to find that the recent violence of the Black People near Lake Lomond has been put down without any sections consequences. Much credit is due to the Volunteers of the Militia who so promptly aided the Civil authority in the just execution of the Laws, which a misguided people had for some time past held at defiance ---We understand that the disturbance was occasioned by the blacks driving off a white man who had got a Grant out for some of the wild Lands originally laid off for thecolored people. It is well understood that the blacks do not " receive their Lands on the same terms as the other Inhabitants of the Province;" they being settled under Locarion Tickets, not transferable --- which are void unless the Lands are settled upon and certain improvements made within a poriod we believe of there years -- the Land contended for was neither improved by or in possession of any one.

Among the Navy Estimates, we find there is an appropriation for this year, to the Bermuda Dock Yard, of £15,000 sterling—£270,910 to complete. £50,000 are to be expended this year at Sheerness yard—£578.838 more will be required;—£25.000 for Plymouth Breakwater this year—£166.182 to complete;—£6000 this year at Kingston, on Lake Ontario, Canada—uncertain what will be required to complete.

Bordeaux Papers to April 25, have been received at New-York.

The French appear to be advancing into Spain at several points.

It is said that the division which will pass into the interior of Catalonia will be composed of from 8 to 2000 men.

It is said that the greatest force of the Spanish Constitutionalists is in Catalonia and Arragon.

An account of the capture of Logrono, by the French, is given—64 officers and 300 muskets were taken.

One account says the Spaniards abandon their homes on the approach of the French.

Vessels were daily arriving at Bayonne, with provision for the troops and fodder for the horses, but were ordered for Bilboa, without discharging.

Letters from Mr. Commissioner Robinson, on the Canada Trade, and Canada Union Bills, communicated by the Lieutenant-Governor, January 22nd, 1823. COPY (E.)

London, 56 Gower Street, April 23rd, 1822.

Sir

The measure of uniting the two Provinces of Canada, on which you did me the honor to confer with me in company with Mr. Osgoode and Mr. Ellice, and also with the Solicitor General of Lower Canada, is one of so great moment to those Colonies, and involves so many considerations, that I feel it due to myself to place before His Majesty's Government in writing what has occurred to me on the subject, though I should do little more than repeat what I have before stated in conversation. You will oblige me by laying before Earl Bathurst the paper which accompanies this letter, in which I have taken the liberty to state plainly such views of the subject as my acquaintance with the situation of Upper Canada, and my opinion of the interests and wishes of his Majesty's subjects there, lead me to entertain.

Having submitted to the consideration of Earl Bathurst, proposed measures for placing the two Canadas on a fair footing with respect to each other, without referrence to any union of the two Provinces, and having now ventured to state explicitly my sentiments upon the expediency of such an union, I have only to add, that I shall be most happy to afford any further information or explanation in my power, and that whatever course His Majesty's Government may determine to adopt upon consideration of the different measures proposed, I shall be equally ready to aid it by any service of mine which can be useful, entirely persuaded, both by the very liberal policy about to be extended to the Canadas with respect to their trade, and by the patient attention which has been given to the different points I am instructed to urge, that the prosperity of those Provinces is earnestly desired by His Majesty, and that no measure will be decided on but in the fullest conviction that it is the one most likely to ensure their security and welfare.
