The Dey's treatment of the Spanish prisoners has been extraordinary. To each sailor he has given the range of the town. and 5 sous per day, for his support. The French Consul at Algiers has also given 5 sous per day to the common sailors, and 10 to the captains.

NEW YORK MAY 7.

Our French papers received by the Don Quixoie, contain intelligence from Constantinople, Feb. 24. stating that the Vice-Roy of Egypt had declared himself independent of the Grand Seignior. This is very important news, if true. The character of this chieftain, his intelligence, activity, and high military name, would naturally lead us 10' expect that he would avail himself of the first good opportunity to throw off the Turkish yoke, and assume the rank and station' of an independent sovereign. And perhapi, the present is as favourable a moment as he could expect. The Octoman power is weak, poor, and to a considerable degree exhausted by its late efforts for its own preservation against the threats of Russia on the one hand, and the Greek insurrection on the other. Unable as the Sublime Porte is to carry on the conflict successfully with the latter, the addition of another insurgent for will have a tendency to distract its counsels, and destroy its remaining energy. From Egypt the Turks expected assistance in their warfare against the Greeks. If instead they should meet with a bold, active, and determined foe, it will add much to their difficulties, and naturally tend to dishearten them. That the news may prove to be true is our most condial wish ; - for if so, we'shall consider it as decisive of Greek emancipanon.
