ces for dispatches by land, which cannot be the case ? should we succeed in finding a passage to the southward of the Pole, we might soon transmit you a letter. Thope I shall have the pleasure of regaling you on board on our return, after a successful voyage round the island of America, with a glass of grog made from the first rum that has accomplished that passage.

KINGSTON, (JAM.) Aug. 31.

The Death Warrants ordering the execution of the Pirates, ten to-morrow, and seven on Wednesday morning, were received in town on Saturday. "

August 25. EXECUTION .- Ten of the unhappy mon condemned to death for acts of piracy and murder, underwent their sentence at an early hour yesterday morning. They embarked at day light under charge of the City Guard in a wherry from the Wherry-Wharf, and the wind being light the wherry was forced to be towed to the place of execution by a row-boat, consequently much delay occurred in their progress to Gallow's point. On arriving off the fatal ground the pirate were assisted out of the wherry into the attending canoes and landed. A subaltern's guard of the 61st. Regiment (which had been sent from port-Royal) formed a street leading from the landing place to the gallows; on the prisoners passing the troops, they closed in & formed a half circle, to protect a space from the approach of the spectators during the continuance of the exeeution. Three Catholic Priests attended and administered religious comfort to the objects of their solicitude who joined in prayer, and appeared fervent in their devotion-The scaffold was first ascended by the Captain, a person apparently about 60 years of age; he mounted the ladder with a firm step, and was followed by his associates in guilt who evinced no indications of fear. During the last melancholy preparations, which occupied some time, several of the sufferers exclaimed, " forgive me, as I forgive all ." Marcellino, the black man, said in Spanish, "I should not be thus, but for the King of Spain and the Authorities at Cuba," thereby implying, as we surmised, that the protection afforded to Piracy by those persons in power, who neglected to exercise their authority had led him progressively to commit those acts for which he was about to suffer. The caps were then drawn over the faces of these miserable objects, and on a sudden signal they were launched into eternity. From the excellent arrangements of the executioner their agony was brief-their death was instantaneous; a slight convulsion was only seen on the limbs of two of the party---Hernandez and Mar-

cellino. Although the countenances of these desperate men before their execution bespoke great mental affliction, they suffered the awful sentence of the law with decency, firmness, and resignation. After hanging their usual time their bodies were cut down and buried in one grave.

The Captain, we learn, was a native of Toulon. A youth, of 17, a native of Martinique, was peculiarly impressive in his devotions. One of the pirates had been a soldier in the battle of Waterloo, where he was wounded; and another had served in the York Chasseurs, and had been long stationed in this Island. Hernandez, the actual murderer of Capt. Underwood and the supercargo of the brig Angus, together with his abettor, the black Marcellino, were the only persons of the party who did not excite the commisseration of the spectators.

Every account from India announces the most extensive preparations to be making for the contest against the Burmese, and for carrying the war on a formidable scale at once into their territories. The struggle we have entered upon in that quarter is the greatest which we have been engaged in, since the overthrow and annihilation of the power of Tippoo Saib. Twenty thousand men, collected from the different Presidencies, are on their march to the scene of action .-

The Supreme Court commenced its Michaelmas Term on Tuesday last, and is Yesterday three Prisoners yet sitting. convicted severally of Grand Larceny, were brought up and received sentence.

The first was Dunean Munn, of the Nashwalk, in the Parish of Saint Mary, charged with stealing cloth and other articles from a Tailor. It appeared that he was pursued with a search warrant directly after the theft was committed, and the articles found in a bundle under his bed. He was sentenced to be whipped twice - 39 lashes at each time.

The next was Henry White, jun. of the same place, charged with stealing an Ox, the property of Peter Fraser, Esq. It appeared that the Ox had been turned out last May on the uninclosed ground of Mr. Fraser's farm in the Parish of Douglas, and strayed down to the Nashwalk, where he was some time after killed by the Prisoner, and the hide sold to Mr. Barker, the Tanner, by means of which the theft was detected --the sentence the same as in the first case.

The other was a black man of the name of Jack Peters, charged with stealing a Fuzee from an Indian of the name of Dennis Acquin, valued by him at £5. From the very good character which this Prisoner had sustained from his infancy until the commission of this crime, the Court sentenced him to pay a fine of £to and the expenses of prosecution, and in the mean time to stand committed. -

We have not been able to obtain the particulars of the very interesting Trial for Murder, which occupied the time of the Court on Saturday for upwaters of fourteen hours. The four Prisoners (John Stewart, Charles Alfred 7. Beardley, Israel West, and Robert Rochford) were acquitted .---We may be able to obtain information by the next week.
