On Friday morning, a Deputation of the Session or Corporation of Saint Andrews Church in this City, consisting of the Minister and the two Senior Elders, waited on His Excellency the Lieutenant-Governor, with the following Address:—

To His Excellency Major-General
Sir Howard Douglas, Bart.
C. B. F. R. S. &c. &c. &c.
Lieutenant Governor and Commander-in-Chief of the Province
of New-Brunswick.

May it please your Excellency—

The Minister and Elders of the Church of Scotland, in the City of Saint John, incorporated by an Act of our Provincial Legislature, and representing a large and important part of the community, beg leave to approach your Excellency with the tribute of our sincere congratulations on your safe arrival in the Province, and the auspicious circumstances in which you have commenced the administration of its Government.

In humbly soliciting that a share of your Excellency's favourable regards may be extended to the infant Church over which we immediately preside, as well as to similar Institutions in connection with the same Parent Church as by Law established, in whatever quarter of the Province they may have been founded, or may yet arise, we are emboldened not only by the past experience we have had of countenance and encouragement from the local Authorities, but also by the fact which we are persuaded has not escaped your Excellency's observation, that His Majesty's Government is now regarding with more marked attention than ever, the claims of the Scottish National Church in the remote Dependencies of the Empire.

And we trust that while in making this appeal, we shall not be found liable to the charge of trespassing on any of those stered obligations under which your Excellency is pledged to act as the Representative of our Gracious Sovereign, in this part of His

Dominions, your own feelings of respect for the Ecclesiastical Constitution of your Native Country, will second the wishes which we thus presume to express.

That the favourable impression made on the public mind by your Excellency's first appearance among us may be strengthened and perpetuated, and that your administration may be long, successful, and happy, is the sincere and fervent prayer of those who now address you.

To which His Excellency was pleased to make the following reply:----

To the Minister and Elders of the Church of Scotland, in the City of Saint John.

GENTLEMEN,

RECEIVE with much satisfaction the congratulations which, representing a large and important part of the community; you offer on my arrival in this Province.

The Ecclesiastical Constitution of our native land, as established and recognised by Law, authorises me to consider the Scottish National Church, as an established Religion in a Colony, the common resort and residence of persons from all parts of our Empire. In this view, I regard, with attention, the claims of the Presbyterian Religion here, in this remote Dependency, as in the Mother Country; and I shall not fail to exiend my favourable regards to the Church over which you preside, in measures connected with the Parent Church of England, so far as may be consistent with those sacred obligations which my duties and persussions oblige me to observe.
