### A Proclamation.

WHEREAS the General Assembly of this Province, stands prorogued to Wednesday the first day of September next, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to the first Wednesday in December next ensuing.

Given under my Hand and Seal, at Fredericton, the twenty-eighth day of August, in the year of our Lord one thousand eight hundred and twenty-four, and in the fifth year of His Majesty's Reign.

HIS Majesty having directed returns to be forthwith made of the general Establishment of the Government of this Province, arranged according to Departments, and including every Individual employed therein, with all the particulars specified in the annexed Schedule, and also a return under similar heads of those public officers who may not be attached to any particular department: all Persons concerned are hereby required in obedience to His Majesty's commands, to forward immediately to this office their respective reports, agreeably to the form prescribed.

Periods during which the officer has been absent on leave from the Colony.  
Whether the Principal or his Deputy enjoy any and what other advantage or profit, not required to be stated in the preceding columns.

Remarks in explanation of the duties of the office and of such subjects as require elucidation.

### ST. JOHN, Sept. 4.

To His Excellency Major-General Sir HOWARD DOUGLAS, Bart. F. R. S. &c. Lt. Governor and Commander in Chief.

SIR,  
May it please your Excellency.

WE, the Undersigned, Clergymen of the United Church of England & Ireland, as by Law established, and the Missionaries of the Incorporated Society for the Propagation of the Gospel in Foreign Parts, resident and serving in His Majesty's Province of New-Brunswick, beg leave most respectfully to offer to your Excellency, our congratulations on your safe arrival in the Government, to which you have been appointed by our Gracious Sovereign: and with them our sincere wishes that your residence therein, may be productive of as much happiness to yourself and family, as it will, we feel convinced, be of advantage to the Province.

At the same time, with all humility and earnestness, we take the liberty of recommending to your Excellency's particular care and regard, the Church to which we have the honor to belong. We might perhaps hesitate to solicit your protection, did we ask it solely for our very work's sake as Individuals; but we ask it chiefly for the sake of the Venerable Society whose servants we are. We also beg your Excellency's patronage for two Societies for Religious purposes, connected with the Church. One of them, the National Society for the Education of the Poor, incorporated in this Province by Royal Charter, by the name of the "Governor and Trustees of the Madras School," your Excellency by the terms of the Charter, is declared Governor and Visitor. The number of Schools amount to thirty-three, and that of the Scholars to 1,340. The other is the Ancient and Venerable Society for Promoting Christian Knowledge. There are here three District Committees whose proceedings have hitherto been far from inconsiderable; but recent arrangements with the Society will enable them materially to enlarge their efforts, and extend their influence.

Sir, we beg to assure you, that our prayers shall continually be offered up to Almighty God, who has commanded that supplications should be made for all that are in authority, that every blessing, spiritual and temporal, may wait upon your Excellency's administration.

May the prayers, Gentlemen, which in your Holy Offices, you offer to Almighty God for all in authority under Him, bring the blessing of His Holy support upon my endeavours to promote the good of His Church and the Prosperity of this Province.

Great Military Review.—On Tuesday morning last pursuant to the particular request of His Excellency the LIEUTENANT-GOVERNOR, the First, part of the Second and the Third Battalions of St. John County Militia, the whole commanded by Major DRURY, assembled on the Sands near the City for the purpose of being reviewed. On no occasion was ever such a numerous assemblage of Militia witnessed at one time in the Province, the numbers as we judged exceeding 1400. Any attempt on our part to comment on the orderly and soldier like behaviour of the whole Brigade, would be superfluous: suffice it therefore to say, that His Excellency's address to them on the Parade spoke volumes in their praise, and drew forth from him assurances of his warmest support. His Excellency, in visiting every section of the Line promised the several Commanders that every thing in his power should be done to make their respective Companies efficient in point of military view.

The animated speech and particular affability of His Excellency drew forth, not only from those under arms, but also the numerous spectators, bursts of applause; and he was repeatedly greeted with loud huzzas.

His Excellency we understand leaves town for the Seat of Government this day or tomorrow, by land.

From the Courier, Sept. 11.

At two o'clock yesterday, His Excellency Sir HOWARD DOUGLAS, accompanied

by Lady DOUGLAS, family and suite, visited the Central Madras School, both the Male and Female Departments, and afterwards inspected the seminary for the Children of People of Colour. His EXCELLENCY expressed himself as the warm friend of these Institutions and seemed gratified with the result of the general view he had taken of the whole establishment.

We understand that His Excellency the LIEUTENANT-GOVERNOR has been pleased to become Patron of the New-Brunswick Society for improving the breed of Horses and other Cattle—of whose objects and arrangements he highly approves—and has with that parental desire to identify himself with the general interests of the Province which has marked the opening of his administration, determined to promote the views of this Institution. We also learn that it is his intention to preside at the General Meeting advertised to take place on the 2d October next.

The Ex-Emperor Iturbide, who arrived at Soto la Marina, on the 14th July—landed on the 15th—was arrested and carried to Padilla—and shot on the 19th. The orders of Congress were, that he should be beheaded. We do not recollect reading of any man, who had reached to such a pinnacle of greatness, and had been hurled from it and lighted, not only uninjured, but with a princely provision for his future subsistence.—It appears to us to have been the summit of folly he should ever again have shown himself among a people who had given him such unequivocal proofs of their dislike; we do not find that a sword was drawn in his cause. His death will not excite much commiseration, but it will in all probability be the means of uniting and strengthening the republican cause in Mexico, and as a necessary consequence hasten the acknowledgment of their independence by Great Britain.—*St. Andrews Herald.*

Hostilities against the Algerines, have been suspended, by the interposition of the Porte, with the view to effect an accommodation with Great Britain.

The British Government by an order in council of June 24, has made some important regulations for the Government of the British Navy. They are comprised in ten chapters.—By one, the ships of the fleet are to be divided into six classes or rates—the first to embrace all three-decked ships—the 2d two decked ships of 80 guns and upwards, &c.—the 6th rate to include vessels of from 24 to 36 guns. All ships are to be rated according to the number of guns they actually carry. Some important regulations are made relative to rank and command. There are to be two ranks of Commodores. Ships of all the six rates are to be commanded by Captains, who are no longer to be called Post Captains, and sloops and bomb-vessels are to be commanded by Commanders, by which title they are to be addressed, and not as Captains. Provision is also made for two new classes of warrant officers to be called Volunteers of the second class, and Master's Assistants.

KINGSTON, JAN. AUG. 5.

His Majesty's schr. Union, Lieutenant Henderson, arrived at Port Royal yesterday, from the Balize, with Francisco Parlabou, a Frenchman, 10 men and a boy; who, in a large row boat, had captured, on the 1st and 3d of April, schrs. Springbird, Emery, with a cargo of flour, and the George Angus, Underwood, from Truxillo for Omoa, with a valuable cargo of dry goods. The cook of the latter vessel jumped overboard and was drowned; and the Pirates put Captain Underwood, and a Mr. Stevenson, Supercargo, barbarously to death. The goods were then landed and
