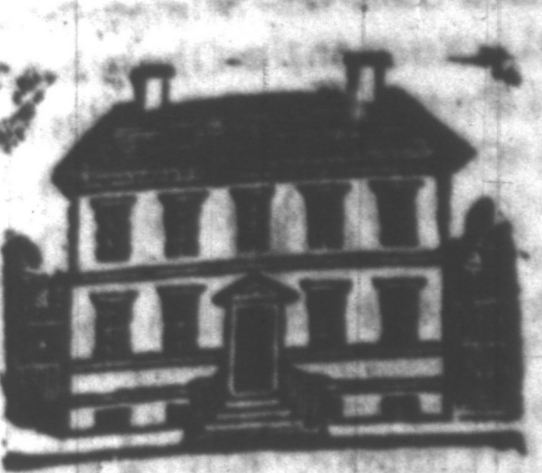

By a Law of the Province, passed the 11th of March, 1824, the penalty for selling Bread of a less weight than the Regulated Assize, is FORFEITURE of the whole for the use of the Poor.
