Telegraphic despatch from Madrid, transmitted from Bayonne, 26th Aug. " MADRID, Aug. 23: 9 P. M. "Gen. Digeon to His Excellency the

Minister of War. The fortress of Tariffa was waken by storm on the 19th, at five o'clock in the afternoon, by the Erench and Spanish troops. The rebels, who retreated into the island, were attacked the next morning at day-break by the landing of French troops of the 31st regiment of the line. One chief only escaped in a boat; the rest were killed or taken.

BOSTON, Oct. 12.

The prisoners have been delivered up to the

Spaniards to be tried according to thefr laws.

A rumor has prevailed of advices having been received from Madrid, stating that Don Francisco, the brother of the King of Spain, is about to proceed to South America. Lord Erskine is appointed ambassador to

the court of Stutgard.

Capr. Bray, who arrived here on Friday from Gibraliar confirms the account of the subjugation of the Smanish Constitutionalists, at Tariffa, and in forms, that 44 of the principal ones had been shot, and that twentytwo others had escaped to Tangeir and placed thep selves under the protection of the American Consul.

The Gibraltar papers appear to be purposely silent as to contests in Spain.

A letter from Gibraltar, dated Sept. 2. after alluding to the taking of Tariffa by a desperate band of Constitutionalists, mentions that after a severe bombardment; by the French, in which they lost several hundred men, the town was retaken by assault; 120 prisoners submitted, and were afterwards shot at Algesiras. The letter adds, "the adjoining neighbourhood of Spain is again quite nanquil."

It seems a handful of Patriots defended Tariffa, 16 days! After they were subdued or destroyed, the country was again " still as death."

The Governor of Gibraltar was accused by the Spanish Gen. O'Donnell, of being privy to the designs of the Spanish Revolutionists. - The British Ambassador resented the accusation.

The French Garrisons at St. Sebastians, Corunna, and Cadiz, are to be reinforced.

I look around with pleasure on the effectual means they are adopting to save from the devouring element (of fire) the property of the Inhabitants of this Town, of which many, I am sorry to say, have at different times, severely suffered; I trust ere the evolution of another month, that the numerous wells now digging, may be in that state of progress, as to supply a sufficiency of water, should any case of emergency require it : But Mr Editor, while they are thus devising means to save the Estates, it is astonishing that one great point should be overlooked, I say, that of the lives of individuals, should any unfortunate being during these dark nights happen to walk in one of these (safety) wells what preventative is there from drowning should the water be six or seven feet deep? or perchance, should he dash his brains out againt the stones at the bottom, or even dislocate his neck, who would be indictable for this death? The answer is easy, nobody, as nobody was the cause.

There are two cases within my knowledge, during the last week of two young Gentlemen falling into one near the head of York Street, providentially, they both escaped unhurt, but this might not be the case with a third, the breaking of a leg or an arm, might be the result, or even worse, as I before said.

Some may rashly suppose that these young men were treading the path of life rather uncautiously, but let them be aware of forming too hasty an opinion, otherwise they will be greatly deceived; as accidents will accrue to the most circumspect.

Mr. Editor, you must be aware, that a few shillings expended in boards or tailings, would be sufficient to debar cattle, and forewarn the unwary of threatning danger; but should it not be deemed necessary to make such a provision, you will oblige by giving this a place (as a caution to others) in some spare corner of your valuable paper. 26th October, 1824.
