SECRETARY'S OFFICE, ] 25th MARCH, 1824. DERSONS desirous of obtaining permission to cut Pine Timber during the Season, are hereby notified that their Petitions may now be received for Licences to be issued after the first of May next. All Petitions for Licences to be in the following Form :---To His Excellency The LieutenantOne Thousand Tons of Timber.

4. That no Licence be granted to any person not being bona fide a British Subject, and a Freeholder and Inhabitant of the Province.

5. That all Applicants for Saw Logs, pay the sum of Two Shillings and Sixpence for every Thousand Feet of Boards into which such Logs are to be sawed, reckoning Three Logs of Eighteen Feet each in length, to the Thousand ; the same to be paid upon the issuing of the Licence.

6. That every Applicant for a Licence shall particularly state his place of residence -that he is a Freeholder in the Province, and bona fide a British Subject; and shall make oath to the truth of his statement, before a Magistrate.

7. Every Applicant for a Licence, to state in his Petition the Mark that he intends to use to distinguish his Timber ; and no Petition to be received without such statement. 8. The Mark stated by the Petitioner, to be endorsed on the Licence; for the information of the Seizing Officer.

9. That no Licence for cutting Timber or Logs upon any Stream, shall embrace both sides of such Stream.

10. That all Licences to be granted, shall expire on the first day of May next ensuing the date of the Licence.

11. That in future, the allowance to Officers seizing Timber, shall be in, lieu of all personal accounts and charges, one-third of the nett proceeds of the Timber seized. 12. The Seizing Officers in the several Districts, to be the Surveyors for laying out the Timber Births in their respective Districts, and no other persons to be employed for that purpose. 13. The Setzing Officers to retain the Licences until they shall have marked off the Births, and if they shall find that any Timber has been cut previous thereto, they are to return the Licences to the Receiver-General's Office, and to seize all Timber which they shall find to have been so cut upon the Land mentioned in such Licence. And such Ligence shall be forfeited, unless the Applicant shall make it appear that such. Timber was not cut by him or for his use. 14. All Timber and Logs found without a Mark, or with any other Mark than that mentioned in the Licence, shall be seized; and any person having a Licence, and being found in possession of more Timber, marked with his Mark, than is expressed in his Licence, the whole shall be seized and forfeited, unless the person claiming such surplus Timber shall make it appear to the satisfaction of the Seizing Officer, that such 15. ## ABERDEEN, MARCH 13.

LONDON .--- Letters by the French Mail state, that the most distressing divisions still exist in many parts of Spain, particularly in Catalonia. Banditti infest the public roads, and even intercept the couriers, so that the inhabitants of towns nearly adjacent are for days deprived of all regular communication. On the 11th of last month the courier from Barcelona to Manzeri was plundered of dispatches of a political nature, which, if delivered, would have compromised the safety of several Constitutionalists of the latter place.

Late accounts from Bayonne observe that the King of Spain has, by advice of the French Ministers dismissed fourteen Ministers of the Castilian Council. Their disgrace is said to be owing to an over liberality in sentiment regarding the long hoped-for act of amnesty. One hundred and fifty persons of liberal opinions have been banished from the capital; the provinces are in the accustomed state of disorder ; liberals have openly banded together in old Castile; and constitutional proclamations have been publicly distributed in Gallicia. A new Ministry is shortly expected. Having changed men so frequently, it would be well were the bigot Ferdinand to try the effect of a change of measures. Zante, Feb. 1 .- Lord Byron has been recognised by the Government of Western Greece as Probedros, or President of Strangers ; over whom he exercises a kind of patronage, which consists in rendering them useful according to their means and capacity. The most perfect harmony reigns amongst all the chiefs, from which the most beneficial results must arise. We understand that dispatches were yesterday received at the Admiralty, from Vice Admiral Sir H. Neale, dated the 25th of Feb. of Algeirs, where Sir Harry was maintaining a strict blockade of that port, in which it was supposed the whole Algerine force was collected. Although it is evident, from the continuation of hostilities, that the Dey had not made the full concessions required of him it is understood that (on the appearance of the British Admiral) he had directed some European captives, lately made; to be placed on the footing of prisoners of war, although they had up to that time been treated as slaves.
