They had however fallen into the unfacky error of all the former Emigrants, -- had a ponderous superfluity of useless baggage along with them---consisting of broken vessels --- old kichen utinsils and crazy pieces of furniture; of no intrinsic value but unnecessary expense in carriage.

## CATTLE SHOW.

The first Cattle Show that has taken place under the Auspices of the newly organized 66 New Brunswick Agricultural and Emi-" grant Society," was held on Wednesday. last on the Race Course in Fredericton; and although there was not that general display of Horned Cattle, Swine or Sheep, that some might have been led to expect, vet it is an event not the less important on that account, being the commencement of a system, which, if well followed up, must ultimately be productive of the greatest advantages to the Province at large, inamuch as it must have a tendancy to create a lively spirit of emulation in the improvement of the breed of all kinds of Stock, and it was with no small degree of pleasure that we observed on Wednesday a display of three years old Coles, which far exceeded our most sanguine expectations, and some of which would have done credit to any Country, and this is only a specimin of what may be expected hereafter from our Cattle. Shows, when that spirit of Emulation which has (in respect to Horses) begun afready to shew itself, becomes more general throughout the Province.

It was not expected by the Central Committee of the Provincial Agricultural Society, nor would it have been reasonable to have look'd for it, that a first exhibition of the kind would produce any thing very extraordinary in every branch of Farming Stock, as there has not yet been time since the organization of the Society, for any material improvements---but now that a commencement has been made, we confidently hope in a few years to see our Cattle Shows not only rival any held in our Sister Colonies but even those of our Neighbours in the States, which must lead to the advancement of the General Agricultural Interests of the Province .-- At present it cannot be denied that our Cattle of all kinds (with a few exceptions) are of very inferior breeds, small growth, and slight make, consequently a very unprofitable kind of Stock to the owners thereof---then with such, and many other prominent evils (in respect to bad seed and bad husbandry in general) existing; surely we are called upon by the duty we owe to each other in the community at large, to use the most strenuous exertions to support every measure likely to produce improvement in those branches, particularly as the best interests of the Province are so materially concerned therein, and what measure so favorable for having that effect as well organized Agricultural Societies? feeling then as we do, we confidently trust that a spirit of determination throughout the Province will be shown, to support the Agricultural Societies that have been, and many hereafter be formed, and thereby enable the directors thereof for the time being to carry into effect all measures likely to produce rapid improvement and permanent advan-

The Show was very numerously attended by persons from various parts of the Province and the weather very fine, but we regret that His Excellency Sir HOWARD DOUGLAS, the enlightened and public spirited Patron of the Provincial Society, was prevented by indisposition from getting to the ground in time for the Show, but having afterwards. arrived with Lady Douglas and Family, the Colts were again brought out, and His Excellency expressed himself highly pleased with their make and symmetry.

The following Prizes were awarded by the Judges appointed for the purpose.

To William F. Odell, Esq. for Syphax the finest g years old Gelding, bred by himself, got by the Chief Justices Horse Lofty, > 210 out of Moll Roe, a brown Mare owned by said William F. O. dell, Esq.

To Jessie Christie, Senr. for the finest 3 years old Bull, bred by \ £5 himself on the Kisway Ridge.

To William F. Odell, Esq. for the finest Boar Pig one year and a half old, bred by the late Judge Chipman at St. John's, from Stock imported by him from Massachusetts.

To Mr. William Miller, of Fredericton, for the finest Sow bred by Mr. John Nevers, from a Chinese breed imported into this ? £1 Province by Anthony Lockwood, Esq. from England.

In addition to the above it is expected that Prizes will be given by the Society to Mr. C. Murray, of Spring Hill, for the second best 3 year old Gelding; and to Mr. Ludlow Campbell of the Nashwalk, for the third best 3 year old Horse Colt, both of which are Colts of great promise, the former we understand was purchased by Wm. F. Odell, Esq. for £40 on the ground, as a march for Syphax.

The weather continued remarkably fine during the Races, but the long drought had rendered the course rather hard and extremes ly dusty; we have seldom witnessed a gayer scene than the numerous assemblage of respectable people, carriages, booths, &c. on a spot so naturally beautiful as the Race Course is generally allowed to be. On the second day the variety of the scene was much heightened by the Military Costumes of the Officers of Militia, who had been reviewed by His Excellency Sir HOWARD Doug-LAS, previous to the Races.

We have no doubt that the giving Plater to be run for every year, will have the effect of encouraging those who breed horses, to take some pains in the cultivation of that valuable branch of rural economy, and we trust that the Races will be carried on with encreasing spirit from year to year as a pub. lic benefit as well as an amusement.
