A MINERALOGICAL DESCRIP-TION OF THE PROVINCE OF NEW-BRUNSWICK.

(Continued.)

The general course of the eastern coasts of North America, is from north east, to south west, while the inland seas and lakes, unite in the most diversified manner, apparently passing in picturesque neglect, the general determination and confinement of the mountains that encircle them. A chain of lofty monntains runs throughout the whole continent ; about three hundred miles from the sea coast, and from the eastern side of them rise many magnificent rivers, running with a winding course into the Atlantic Ocean.

The Province of New-Brunswick, fotmerly a geographical division of Acadia, is of an irregular conchoidal form, and of unequal extent, some of its lateral extremities, having an inclination of more than 70° to the north.

Its interior structure exhibits the wild features of nature, diversified by frequent geological phenomens, and where the latter predominate, -- the profile of mountain and forest groups, the Valleys, Lakes and Rivers, scooped amidst all angles of direction, and the changing of the axis of rotation, throwing all the scenery that bounds the horizon into picturesque derangement, give this section of America an enchanting appearance in the eyes of beholders. Nature has reserved particular spots on the earth, where her benevolent hand has bestowed every kind of richis sie shews us here that even in the northern regions, in this sequestered tract, she can consecrate to herself a sanctuary, which she is pleased to decorate with every sort of ornament. Nearly in a parallel of latitude with Greece, the inhabitants of this tract of cout try, want only the fine climate of the former, to make their situation the happiest that could be assigned them. Aimosphere, Soil, Water, Lake and River Scenery. Geology, Geological phenomena, Minerals, Fossils, &c. The above classification embraces all the topics, connected with a mineralogical description of this Province, and an investigation of these in order, will now be attempted. The climate of a country is not more dependent on its proximity to the equator, than its situation. In the same latitude one continent is hotter than another, and one side of the same continent, than the other side. While in the same tract, a plain is warmer than a mountain. The geographical aspect of this Province, the surfaces of its large rivers, its numerous lakes, fenny and marshy lands, the vast Atlantic Ocean that borders its coast, the propinquity of that fountain of exhalations, the St. Lawrence, the exuberant transpiration of the soil, and the dense empire of the forest, -all contribute to render its atmosphere moist, and variable. These circumstances operate also to prevent any two successive seasons being alike, and occasion nightly frosts in every month in the year, except
