The thermometer has been known with a northern aspect, even the mercury is frozen at times, while in the months of July and August, it is often known to rise to 98°.

## SUMMARY.

A Russian Imperial Decree, dated April 23, after declaring that it is principally the Jews who are concerned in contraband trade, orders all persons of that religion to settle in the interior of the Empire at the distance of 50 wersts from the western frontier. They are prohibited from residing in the provinces of Astracan and Caucasus.

STRASBURGH, Aug. 6.—The drought has so diminished the water of one of the Farms of the Ill, at the village of Ehl, near Renfield, or the ancient site of a Roman Town, that the bed of it, can be dug up. Roman medals, rings, keys, agrafles, and other antique ornaments, have been dug up. As soon as the Prefect was informed of it, he sent an engineer to the spot to direct the excavations and to take care that what is found shall not be destroyed and lost to the Arts.

The heat of the air on the Red Sea is above blood heat, even at night, and on the gold Coast has been felt above 114 in the shade; the natives themselves are obliged to decamp southward during the summer. In Lisbon 98 is a common shade heat for months together; and a few years since, it was for a long time 104 and 105. Africa is the hottest portion of the earth; presenting the greatest mass of land, or rather sand, to be found under the equator.

Letters from Gibraltar of the 1st inst, confirm the failure of the crops in the South of Spain.

Letters dated the 15th of June have been received from Cape Coast. The soldiers were beginning to feel the effects of the climate. Lieut. Colonel Purdon, of the Royal African Colonial Corps, had experienced an attack of fever, but was recovering; we are sorry however to add, that Capt. De Barrallier died, after a few days illness. No mention is made of the Ashantees.

The price of butter in England now ranges from 102s. to 57s. per cwt—that is from 6d to 11d per lb.

We find in a Parliamentary Paper that the quantity of fir imported last year into the United Kingdom, amounts to 581,200 loads, or 23,248,000 solid feet; besides about 4.250.000 Baltic deals, 1,400,000 deal ends, and 15.000 masts. The value of the great quantity of fir timber exceeds three millions sterling.

A destructive fire broke out in the buildings near the Brunswick Docks, Liverpool, on Friday last; five vessels in progress of building were burnt; one a steam vessel nearly ready for launching, and another in the same state, a vessel of 400 tons burther. One man perished in the flames. The loss is estimated at £50,000.

One of the largest steam engines now in use is at the United Mine, in Cornwall. It raises 80,000 pounds 100 feet high per minute, with about 30 lbs. coals, and is equivalent to about the power of 250 horses.

L659,577 was paid into the Stamp Office last year by forty-six Insurance Companies, at 3s for every £100, the total property insured amounts to £430,685,000.

A white porpoise was shot last week off Millport, Scotland, the first ever scen by the oldest fishers.

Lawson, Albro, Fairbanks and Hartshorne, members of the Legislative Assembly, that His Excellency should be requested to order the sum £1,000 to be drawn from the Provincial Treasury, in addition to the contributions made on this melancholy occasion; and a Committee, consisting of the Hon. the Attorney General, Judge Haliburton and Enos Collins, was nominated to confer with S. Cunard, S. Deblois, James Tobin, G. N. Russell and John Clark, Esqrs. a Committee chosen by the town, on the best and most expeditious method of assisting the houseless and wretched people.

On Tuesday H. M. Ship Orestes; schooners Active, Albion, and Elizabeth, with provisions, clothing, &c. for the unfortunate people, sailed for Miramichi.
