are but the prelude of still greater, which, menace this wretched country, if the drought, should continue a few days longer. For six months not a drop of water has fallen, and the fields resemble the deserts of Africa. --- Lon. Paper.

BOSTON, June 4.

From Peru .- Extract from Bolivar's second refusal of the Millions of Dollars decreed to him by Peru .- . " I repeat, that without accepting the favour in question, my services have already been rewarded in an infinitely greater degree than had ever been hoped. Your Excellency knows," [he addresses the President, ] " that Congress has omitted nothing calculated to be honorable to me. They have named me Father and Saviour of Peru; they have decreed me the honors of Perpetual President; they have ordered a medal to be struck with my portrait; they have called me Liberator, they have invested me with the command of Peru; and finally offered me an enormous fortune. I have accepted with pleasure all except the last; that I am forbidden to accept by the laws of my country and those of my own heart."

Extract from the reply of the President. "EXCELLENT SIR, --- The Congress to whom I have made known the repeated and absolute negative of your Excellency to receive the million of dollars which they decreed to place at your disposition, as a slight testimony of the inestimable benefits for which the nation are indebted to you have determined, that I shall inform your excellency that while they respect your decision, they sensibly regret to see their designs on this subject frustraited; and that not feeling themselves at liberty to press it a third time after the decided expressions contained in your last note, take the liberty yet to request that you will appropriate the said millions to works of benence in favour of the fortunate place of your nativity, and for other parts of the Republic of Colombia which you may think proper.

#### NEW YORK, JUNE 10.

The Late Gale .- It will be seen by our Nortolk accounts, that considerable damage was done to the Shipping at that place, in Hampion Roads. &c. The gale commenced at Norfolk four hours earlier than it did in this harbor.

We learn from Cape Island, that it was almost inundated during the lare gale --- scarce -Iy a fence or shed was left standing.

The accounts from Edenion are very disasterous. The rain was tremendous, and the whole country inundated -- trees torn up, and fences. & prostrated.

Most of our citizens, says the Freeman's Journal of yesterday, are not aware that during the storm on Saturday night last, the ground was entirely covered with snow. This is unprecedented in the month of June. In New York snow fell in Aug.

Levers from Bordeaux of the 23d, state, that several frosts had occurred the two preceding nights, which, it was feared would greatly injure the vintage. The Paris Papers says, that from all accounts received from several of the countries, the crops there will not be more than half to two thirds an ordinary crop.

### HALIFAX, June 15.

His Excellency Sir Howard Doug-LAS, Bart. arrived in town, from N.-Brunswick, about 4 o'clock of Thursday afternoon, having passed the preceding day at Mount Uniacke. On His Excellency's arrival being announced, a salute was fired from Fort Charlotte. It is, we understand, His Excellency's intention to proceed from hence to Miramichi.

Mr. HALL has, we are told, completed his survey of the Shubenacadie, &c. and is now engaged in sketching a plan and estimate of the projected work; the probable expence of which, it is said, will be far within the former calculation .-- W. C.

The delay in the arrival of the Eastern Mail on Saturday, was occasioned by an occurrence of a serious nature. About half past nine o'clock, on Friday evening, as the Posman was passing over the Chiganoise Bridge, his Horse was struck by lightning, and, with himself and Mails, precipitated into the River, about four and twenty feet.

The Postman fortunately escaped unhurt but several hours elapsed before he could procure another horse to enable him to proceed on his journey .-- Hal. Jour.

That no Fish, Fresh meat, or Poul. try, of any kind, or Butter, shall be sold in any private Stall or Shambles, or in any part of the Town of Fredericton, until the same shall have been regularly exposed for sale in the Market-House for the space of

Two Hours, under the penalty of Twenty Shillings for each and every offence. 3d. That no person shall purchase any Fish, Fresh Meat, or Poultry, of any kind, or Butter, in the said Market, for the purpose of selling the same again, until after the same shall have been exposed for sale in

the Market House for at least two hours, under the penalty of Twenty Shillings for each and every offence.

4th. That the Clerk of the Market be directed to have some safe place in the Market House for the lodgement of articles brought in the evening, and that he further be directed, to employ a person to keep the passages inside and outside of the Building, in decent order.
