From the M. Manuscript of -- for June 1822. Consulto, maturato, invento, facto, &c.

Left Dublin 6 a. m. 28th of May, arrived at Clonmel at 10 a. m. of the 29th. The Country about Clonmel is considerably mountainous. There is a lofty ridge of bleak hills commencing exactly at the south side of the Suir. The huge mountain called Slæve-na-mon (or some Irish name like that) is perhaps the highest in Ireland. The summit is generally embraced by the sweeping clouds of the lower region of the Atmosphere; and in the winter, it is in a perpetual storm of snow. On Sabbath, 2d June, I attended public worship in the Church, which is a modern Gothic Structure. The Church Yard is agreeably set with stately Trees, which particularly adorn the avenues, and the whole has an air of solemnity consonant to the approach of a place sacred to the worship of Him whose Temple is all Space. On several of the Tomb-Stones may be read some curious and even appropriate Epitaphs; but many are ludicrous and absurd in the extreme. The good people called Friends (or Quakers) seem to have monopolized, in a great measure, the fatest emoluments of the Clonmel trade; but certainly by all fair and legal means.

On Monday June 10, I went to Cashel.

In the evening visited the ruins of an ancient Castle situated on an abrupt elevation on the N. side of the City (as it is called). This place is said to have been the residence of the ancient Kings of Munster. It was evidently constructed more with a view of desence, than either convenience or oinament .-- The architecture is ancient Gothic, and the whole has something of dignity in its aspect, when considered from a distance. I regretted seriously I had no person of any liverary intelligence along with me; but while I was very pensive about this, behold! a drunken old woman made her appearance from some cell adjacent to the Ruins. If she had been in a state of sobriety, I would have been ready to consider her in the capacity of an Antiquarian so far as related to this place; but shame on her ! she was in a state of abominable inebriety, and could not find the Key to open the gate which led to the interior of the ruins, and for which she was venting vengeful and disgusting ravings; apparently on this occasion, as she anticipated her payment would be less, inasmuch as she could not satisfy the curiosity of the Visitors. It is to be observed that she was the keeper of this ancient, but ruinous Palace

The Country in the neighborhood of Cashel, was under the operation of the Insurrection Act, lately passed for the suppression of the extraordinary disorders and deeds of wickedness which prevailed in this direction. Yea, deeds of enormous wickedness and cruelty, the most black and diabolical as ever disgraced the annals of degraded humanity!! If the people laboured under any political or private oppression, why not redress their wrongs by some legal means, or at any rate act somewhat like men?

I left Clonmel at 2 p. m. on the 25th of June, and was at Grangemouth on the Frith of Forth (Scotland) on the 29th. was urgently advised here to adopt regular measures for being released from my engagements to return to Clormel; but my inconsiderate rejection of this very salutary and prudent advice, has subjected me to the swallowing of some nauseous draughts* of inexecrable memory.
