We have been permitted to make the following extract from a letter, dated Turk's Island, August 2, and addressed to a house in this city:

"I am sorry to inform you that the salt season has proved very unfavorable, that a severe hurricane on the 2d ult. destroyed a considerable part of the Salt that had been gathered. It will therefore be impossible to collect from those who have lost nearly all their Salt, the debts they owe, and we must wait another season for the payment. The Salt that now remains, belongs to a few individuals .- Conn. Mirror.

From Montevideo .- Captain Heath arrived at Boston from Montevideo, which place he left on the 7th July, states that 3 vessels of war sailed from that place for Bueno: Ayres, to ascertain if that Government intended to assist the revolutionists, and in the event of receiving an answer in the affirmative, it was to be considered by the Emperor of Brazils tantamount to a declaration of war, and measures adopted accordingly. Great preparations were making at Montevideo, in anticipation that such would be the result on the return of the vessels of war. All the vessels of war and about twenty five gun boats in Montevideo, were preparing for actual service. There were from 5 to 8,000 troops in the city. -The Revolutionists without, permitted nothing to pass into the City, without first re, ceiving a heavy duty upon it. Flour at Montevideo was 18 mill reas - none in mar-

Extract of a letter from Pernambuco, dated 21st June, 1825.

"An order has been received here from the Emperor, directing Mr. Ray to leave the country-First, because he supported M. Curvalhos. Second, because he saved the lives of 20 persons. Third, because he assisted persons in the revolution of 1817 to get away -among them were the friends of the Emperor himself. The whole city is interested about it, and numberless petitions have been sent on to the Emperor. The public abhorrence is very great.

A subscription for the Greeks was made at the Paris Exchange on the 12th ult .-More than 2,000,000 francs, nearly 400,-000 dollars, were collected in one day.

The French force in Spain is to be reduced to 10,000 in April next.

The Plague. - Late Leners from Marseilles announce the arrival there of a vessel from Alexandria, with four of her crew dead of the plague, and that it raged in that city with great intensity.

The population of Cadiz, formerly 65,-000, is at present reduced to 40,000. Many mercantile establishments are about to leave the place, and one third of the dwellings are empty.

bank notes, 512 of which weigh one pound. Supposing the debt to be only 726 millions of pounds sterling, it would weigh 142,650 lbs., which, for 300 men, would be 476 lbs. each.

A few days ago was sold, at Evans's, Pall Mall, for £33 12s. to the Duke of Buckingham, the first tract ever published upon America. It was the celebrated Letter of Columbus, which was long supposed to have been lost, and was unknown to Robertson when he wrote his History of America. There were two editions printed, one with a date and the other without. So excessively rare is this edition with a date, that it has been said that the only copy besides this is the one formerly in the possession of Don. J. A. Conde, and now in the ilbiary of the Right 11on. I. Grenville, and published May, 1493.

Gold and Silver .- From the 5th April to the 1st of July, £2,834,000 in gold & silver have been exported from this country, as made up from the Custom house books: viz. In the month of April, £1,050,000; May, £390,000; June, £1,424,000.... or at the rate of nearly one million per month.

Advices from the Cape of Good Hope, give us reason to believe that Lord Charles Somerse; will be in a manner compelled to come over and defend himself from the charges which have been made against him. It is said that Lord Bathurst had communicated to the Governor the long catalogue of accusations against him, and had intimated that as his Lordship might find it expedient to return to England and defend himself, he (Lord Charles) had the authority of Ministers to request Sir Lowry Cole, British Governor at the Isle of France, to repair to the Cape and officiate as Governor ad inte-

Two camps are about to be formed upon the frontiers of France, toward Spain, but whether the forces they contain are to stand as corps of observation, instead of the army of occupation, or to aid it in case of need, is not at present made known. We are informed the intention is to prepare for the evacuation of the Peninsula. The fact of the formation of the camps we are enabled to say is certain .- (Globe.)

Provision Contract .- The unusually large contract, the tenders of which have been advertised by the Victualling Department, has attracted great attention in the city to day ? it is for 13.000 tierces of Pork, and 16,000 tierces of Beef; and it is larger by 9,000 tierces than any other contract for provisions since the Peace. It has been looked upon by many almost in the light of a war contract, and not a few have coupled it with the numerous Cabinet Councils recently held in Downing-street. (Dublin Evening Post.)
