ALL Persons who have received and who have not yet accounted for the Expenditure of any public monies entrusted to their care and expenditure, are hereby required to make up and transmit their several Accounts (post paid) to this office duly attested, and with the proper Vouchers in their support, by the first day of December next, or their Defaults will be reported to His Excellency the Lieutenant Governor as directed by the Act of Assembly "for the better examining and auditing the Public Accounts of this Province."

The Accounts must be stated Dr. & Cr. with the Province, and the warrants credited each separately, and the purpose for which granted. The payments made must have distinct Vouchers applying to each Charge and corresponding in number and Amount: The Accounts must state whether any and what parts of the work have been done by Contract, also the names of the Contractors, the nature of the contract, whether by the rod or other distance, or so much for the whole, or in what other way? how the Contract has been performed and what sums have actually been paid?—If done by Days-work to state the names of the workmen, the rate of wages per day of each man whether found in provisions or not? the number of days which each man has worked, the amount paid to each man, the quantity of work done, and the mode in which the same has been performed; The proper receipts must accompany the accounts of all monies paid by the commissioners, and (if the same are Signed with a mark) they must be witnessed by at least one respectable witness:—The Commissioners Account must be attested to before a Justice of the Peace, and the Oath must be in the following form, or to that effect viz. "We A. B. & C. D. the Commissioners within named do make Oath that the foregoing Account is correct and true, and that the

"several sums therein mentioned as paid have actually been paid by us as therein stated"

Corn Laws.—The following paragraph will be read with interest: "We understand" says the Liverpool Mercury of 15th ult. "that the plan meant to be proposed to Parliament by Ministers for the modification of the Corn Laws is to impose a duty on the importation of foreign grain of from 1s. to 30s. to be regulated by a graduated scale, beginning at 1s. per quarter on wheat when the average price in England is 69s. and increasing to 20s. when it is as low as 50s. and suffering the importation to be perfectly free when it is 70s. or upwards."

STATE OF IRELAND.

(From the Dublin Even. Post Sept. 15.)

We regret to state, that we have received accounts from several parts of the Country of a very gloomy and discouraging nature. In Cork the distress continues, we grieve to find, without any sensible abatement. The contributions, we are told in a letter, now lying on our table, are nearly exhausted; and in reference to this subject we find that a parish meeting has been called at Cork, and a counter-petition got up against the general petition in favour of a modified system of Poor Laws. But the gentlemen of Cork may rely upon it, that the subject will be taken into consideration by Parliament, and that the petition from the city, which we still think the most important that has ever been agreed to in Ireland for many years, will receive a very peculiar degree of attention from the Legislature. To wave however, a discussion on this question for the present—we would ask the people of Cork, of Tipperary, of Waterford, and of Dublin, how they are to provide for the poor in the coming winter months?—We know that starvation prevails to a most horrible and appalling extent. We know that fever has not yet decreased—and that cholera morbus, and particularly dysentery, have been, and continue rapidly on
