They found the Greeks very well forsified there, and learnt that Karais kaki had just gained a brilliant victory. Then the troops in the Piræus, in concert with the garrison of the Actopolis, attacked, Bishop Portens' Bibie [[Littleton's Life of Same the Seraskier in his camp. The attack was completely successful; the Gre ks entirely_defeated the Turks took a great quantity of provisions. &c. and returned into the fortress, which has now a very good stock of provisions. , the heroine, Madame In this Goura, wife of the celebrated General of that Lowin on Isaiah, Septu II - Fathers, name, was killed at the head of her troops, after baving shown herself worthy of the reputation of her husband. Karaiskaki has fixed his camp at Eleusis, where he has effected his junction with the old Caratasso, and the patriot Coletti.
