GREEK AFFAIRS.

The Greeks had obtained advantages in different parts of Western Greece; Karaiskaki was in the vicinity of Lepanto, after having raised the whole country between Missolonghi and Salona, Athens, though closely blockaded by about 5000 Turkish troops, held out most bravely, not without some apprehensions entertained of its falling into the hands of the Turks. March 18. All the European Ministers at Pera have made representation to the Emperor on the subject of the pacification of Greece, and have advised him to close with the propositions of Russia and England. Many persons regard as a complete accession to the peace of the occurrences of St. Petersburg of the 4th April, while others would point out a difference between the menacing attitude taken by the English and Russian Ministers, and that of the other Ministers, who limit themselves to simply recommending that their propositions may be accepted.

NAPOLI DI ROMANIA, March 2.

(Private Correspondence.)—The death of the unfortunate Colonel Bourdoeki is confirmed. His head was carried in triumph by the Turks up to the walls of the Acropolis. The Greeks composing the garrison, alarmed at the ill success of the troops of the camp without, sent out in the night two brave Palicars, who passed through the enemy's army to get to the Piræus, in order to obtain correct information respecting this unfortunate affair. They found the Greeks very well fortified there, and learnt that Karaiskaki had just gained a brilliant victory. Then the troops in the Piræus, in concert with the garrison of the Acropolis, attacked the Seraskier in his camp.

The attack was completely successful; the Greeks entirely defeated the Turks, took a great quantity of provisions, &c. and returned into the fortress, which has now a very good stock of provisions.

In this heroine, Madame Goura, wife of the celebrated General of that name, was killed at the head of her troops, after having shown herself worthy of the reputation of her husband. Karaiskaki has fixed his camp at Eleusis, where he has effected his junction with the old Caratasso, and the patriot Coletti.

Omor Pacha, after having been defeated by Karaiskaki, at Disiomo, took to flight, leaving all his baggage and artillery, which now serves the Greeks. A great number of his men were taken prisoners, who were put to death, to revenge the assassination of Bourdoeki.

The Hellas frigate, commanded by Miaulis, is at Negropont with a strong division, to hinder provisions from reaching the camp of the Seraskier. The Government is taking the most energetic measures to drive the Turks from before Athens; Fabvier is still in the Acropolis. Missolonghi is closely blockaded by General Makri; that place must soon surrender, being in want of provisions.

Commodore Hamilton is still at Egine, the seat of Government, while Admiral de Rigny remains at Smyrna, and does not show himself any more in our seas.

The American crew of the Hellas has returned to America, on board a frigate of that nation.

Miaulis is appointed High Admiral of the whole Greek Navy. Paulocet, who commanded the Austrian squadron, is succeeded by Dandolo.

Mayrocordat has been banished to Syria by a decision of the Government. Dr. Bailly continues to merit the esteem of the Greeks, by his humanity to the sick. He is now attending Colonel Raybaud, whose wounds are beginning to heal.

The new Assembly is to meet at Castro. It is generally believed, that the searoy will make Condaridu President of the Government; but the army would prefer Count Vissioke Capo d'Istria, brother to the Ex-Russian minister.

From the Atlas, April 29

Lord Cochrane has at length reached the shores of Greece. He entered the port of Nauplia on the 16th of March amidst enthusiastic demonstrations of joy, and almost immediately sailed with a numerous fleet, which had been long preparing. Many of the vessels are said to carry from eighteen to twenty-four guns, besides the large frigate built at New-York, steam boats, &c. The total military force of the Greeks is 28,300.
